# ALACHUA TIM TEAM MEETING WEDNESDAY, OCTOBER 14, 2009

# **MEETING MINUTES**

For the list of attendees, please see the attached sign in sheet.

Donna Danson opened the meeting by asking everyone to introduce themselves.

Donna stated the purpose of the meeting - to maintain appropriate communications between member agencies and discuss any issues that have occurred during recent incidents, so that future incidents can be handled in the most effective manner.

Laurie Windham gave the Construction update

- 441/13<sup>TH</sup> street paving is complete. Repairs are being done to the sidewalks and the Contractor is currently installing ADA ramps.
- Overpass over 8<sup>th</sup> Ave is being worked on and there will be some lane closures, but that is a few weeks out.
- SR 26 Orange Heights overpass over 301 and railroad tracks, test piles are being done this week.
- Main St. Project currently has 2 southbound lanes closed and two-way traffic is on the northbound lanes.
- Stimulus Contracts:
  - Main St. north of 8<sup>th</sup> Ave to 16<sup>th</sup> street is reducing to 2 lanes and 16<sup>th</sup> to 23<sup>rd</sup> streets will be resurfaced. Project will begin in a few weeks.
  - US 41 is getting a turn lane added south of 26<sup>th</sup> at 30<sup>th</sup> Ave near Newberry, also paving between a half mile and a mile on 30<sup>th</sup> Ave.
  - Steve Scanlan added the project working on the retaining wall at Archer and 13<sup>th</sup> Street, which will affect the sidewalk in the area when they are removing existing block.

Donna the asked Ed ward to give the EOC update

• Ed stated that there is nothing to report and everything is going surprisingly well.

Chris Dolan gave updates for ITS and Traffic Signal work for Gainesville

- 71 PTZ cameras are on-line
- 115 Signal Controllers have been changed out to new Naztec Controllers
- 20 new cabinets have been received and will be installed soon.
- Most of the new controllers and CCTV's are on fiber, but the City is also experimenting some with wireless.
- TMC ground breaking on 10/26/09 to be completed in 1.5 2 years.

# Next Donna gave a RISC update

- Alachua now has a RISC Contractor on board, University Towing; once the contract is activated Donna will let everyone know.
  - At the end of the meeting Donna had received an update that the Contract has been executed.

Craig then gave an update of existing and upcoming ITS projects

- We have completed an estimate for an ITS system on I-75 that will be about a 9.5 million dollar system. The cost estimate was broken down into three different segments. If you have any questions please contact Pete Vega
- In the Jacksonville area, Phase 6 (I-95 and I-295 South Interchange to the St. Johns County Rest Area) is about ready to break ground, Phase 7 (SR 9A from Atlantic Blvd to the North I-95/I-295 Interchange) is under design, 60% plans have been submitted and we are looking for comments back sometime in early November. Phase 8 (I-295 from I-10 to the northern I-95/I-295 Interchange), the designer is on board and negotiations are in the works.
- The TPO is paying for some projects to put CCTV cameras and arterial dynamic message signs on several arterials around Jacksonville, including portions of SR 21, US 17, US 1, A1A in St. Johns County and SR 200 in Nassau County.

Penny Kamish gave an overview of the new 511 system

Still working on some of the voice recognition and response features. We still
need help from all of our TIM Members to let us know traffic information. Also, if
you encounter something while using the 511 system please leave feedback.

Next Donna asked if everyone had a copy of the incident spreadsheet that was prepared by Ed Ward. She asked that everyone review the incidents to see if they had any comments.

- Mike Goodman stated that like the 9/20 incident at US 301 and SR 20 in Hawthorne there have been several accidents in the same area and they have received several complaints with the layout of the intersection and the light. Gina Busscher stated that Traffic Ops is looking into this to see if it is a problem and what can be done to correct any issues that may be found.
- There have been several accidents, including a few fatalities in the area North of the SR 222/SR 26. Feeling from Team Members was the majority of the incidents have been due to the vehicle traveling at a high rate of speed and this may be partially contributed to the re-design of the interchange so that SR 26 portion was straightened out and this now allows motorists to drive faster through this area.
- Bruce Strickland asked if the US 441 accident had been finalized. FHP trooper, John Gourley, stated that the report is not final but thanked FDOT for their support during the several days that it took divers to find the body that was ejected into Paynes Prairie.
- Rick with University Towing asked about the incident with chlorine gas, which closed I-75 and diverted traffic to I-10. The semi was carrying small containers of

- chlorine gas that did not require the truck to have placards, but so many of the containers ruptured that it was a big problem.
- Donna mentioned that this issue was discussed at the First Coast TIM Meeting.
   Kenton Brown is putting together a training to give in Jacksonville and any of the Alachua TIM Team members are welcome to attend this training.
- Steve Scanlan wanted to thank everyone for their support, in particular with some of the recent accidents and events.
- Donna stated that the Waldo Police Chief Mike Szabo had requested equipment from the team. Steve Scanlan responded to his request by loaning traffic cones and arrow boards to assist with MOT.

# Next Donna gave the general announcements:

- Donna mentioned the retirement of District 2 Secretary Charlie Baldwin.
- Donna also mentioned the retirement of Jim Scott and his new replacement Jerry Ausher who will be starting in 2 weeks.
- Donna discussed the TIMe4Safety Training videos and manuals. FDOT Central Office will be providing DVDs of the modules to each of the responding agencies.
- Central office has a goal to have all responders trained by the end of 2010, they are calling this TIM in 10.

Donna introduced John Long with Florida Gas Transmission Company, who then gave a presentation on the location of Florida Gas lines and what to do in case an incident is on or near these lines.

Donna thanked everyone for their participation in the TIM Team and adjourned the meeting.
