### First Coast TIM Meeting Tuesday, September 21, 2010

### Meeting Minutes

The list of meeting attendees and the Meeting Agenda are attached to these meeting minutes.

 Donna Danson welcomed everyone and stated the purpose of the TIM meeting to achieve the mission and vision to have the best incident management team. She thanked everyone for working together well as a team.

Donna asked the team members in attendance to introduce themselves.

• Patrick Odom from Central Office in Tallahassee was introduced and was available to answer questions.

Meeting minutes from the July TIM meeting were approved.

• Mike Goldman gave the construction update.

• Clay County – Traffic will go on Plantation Oaks Boulevard bridge Sunday night

• I-10/I-95 project – all traffic movements are open but work will continue for the next several months.

• US 17 bridge at Doctors Inlet – the work will end in mid-October

 Donna Danson gave the Emergency operations update for Ed Ward since he was unable to be present.

• There are many hurricanes and storms and although they have not hit our area yet, the team was reminded the need to be prepared for such an event.

Donna Danson gave the ITS Update since Pete Vega was not present.

• RTMC – North Florida TPO board has committed \$9 million to begin construction in July 2012. There are other funding sources that could possibly become available. If they were to become available for the RTMC, construction would begin sooner.

• Blanding Boulevard project is two weeks behind schedule. It is hoped that acceptance will be received before Christmas.

• TERL – Express 840 switch has been approved. It is needed to operate the city's traffic signals. It has been ordered and should begin installation in the next few weeks. It is hoped that operation will begin before the holidays. Target roadways are SR 13, Blanding Blvd, Roosevelt Blvd, Beach Blvd (after holidays) and Baymeadows Rd.

• US 17 project in Duval and Clay counties – Design is being completed and construction will begin soon.

• US 1 project is under protest

• SR 9A – contractor should be on board in October. It is about a 400day project, but may be finished sooner.

• RWIS – Bridge mounted instrument that give data making it possible to decide whether or not to close a bridge without having to send a person out onto the bridge. Hope to get funding in October. If funding is received, a partnership with NOAA will be formed and data will be sent from NOAA's satellites to Lake City office.

• I-295 NW quadrant – completing design and a contractor should be on board in April, 2011.

• Transpo 2010 will be held at Sawgrass in December. Contact Pete for more information.

Sean Wilcox gave the 511 Update

• Positive improvements seen with Road Rangers in regard to communication due to some training sessions group meetings.

• FHP TMC has a new video wall that is considerably better than the previous wall.

• Emphasis has been placed on utilizing safe tows especially at the I-10/I-95 corridor. The goal is to clear the road immediately.

• Would still use normal wrecker rotation. Safe tow is just to get the vehicle out of the travel lane or to a safer location.

 If Road Ranger feels endangered they can request to have the vehicle moved.

• Example was given that in District 4 a Road Ranger and trooper were hurt badly. This highlighted the importance of utilizing the safe tow.

D2 Road Ranger Contract provides wreckers for Safe Tows.

• The Road Ranger Operator can request a Safe Tow via the TMC operator with TMC Supervisor approval. Road Ranger contractor is contacted. All information is recorded.

Safe Tow is free service and has proven to be quick and successful.
The service was requested by FDOT.

• Regained use of I-10 DMS by Ramona. It is in service now.

- Incident Debrief
- Crashes yesterday, 9/20/10 are not on list

o I-95 – fatality at Emerson in afternoon, 9/20, 3 investigations were conducted

• I-295 / I-10 per Rodger, there was "confusion between the Road Rangers and JSO" There were at least four short lane closures until Jorgenson arrived and reset MOT properly. Jorgenson was at the incident on I-95 at Emerson when they were called about the incident on I-295 so it took 30 to 40 minutes for them to reach the incident on I-295. There was confusion about what would happen when life flight arrived. (Since JSO or FHP had no representation present, all discussion was tabled.)

• I-95 at Phillips, overturned vehicle, just before 5pm. A second wrecker had to come to the scene to assist where the first wrecker could not execute. JFRD had left scene but had to return because Jorgenson noticed that the vehicle started to leak fuel. Concern was raised that wreckers are not thoroughly trained for recovery responses. (Various efforts have been and are being made to resolve the issue.)

• FHP has been reminded RISC is available.

• Patrick Odom– Gave an example of a case in Fort Lauderdale. The Fire department would not leave the scene until the vehicle was righted. Asked if JFRD should have left before the vehicle was righted. A clear answer was not available. He also mentioned that in that same case, the Road Ranger used a <sup>3</sup>/<sub>4</sub> ton truck with chains to overturn the vehicle without the use of a wrecker.

• Roger stated that it is important to clear the roadway of disabled and abandoned vehicles since one of the fatality crashes yesterday was a hospice van that his a disabled semi truck. It was confirmed that the semi did have reflective triangles properly placed.

• I-10 incident at Chaffee was not deemed RISC because it was in the West bound direction

Jill Dawson discussed the Performance Measures

• Jill stated that performance measures are going to be used to monitor contributing factors toward the incident duration time.

• Agency response times report pertains to the TIM team is found in the SunGuide system. It gives the average response time and average on scene time for individual agencies.

• A handout was given that displayed graphs of the data taken from the agency response times report for each of the past 6 months for crash events and also all events.

• The data was reviewed and team members were asked for comments.

• Roger from FDOT Maintenance asked if the notification time for maintenance begins when they are made aware of the situation or when they are told that FHP has requested their response. Donna asked Sean to follow up on this and give a response to Roger.

### Concerns

• I-10/Chaffee Crash- problem where TMC operators contacted maintenance before construction. This has been addressed with operators and issues already discussed.

Road Ranger Update

• Jamie Scarberry expressed appreciation for the DMS signs being used to warn motorists when the Road Rangers are further ahead on the roadway.

• Greg Gaylord stated they have actively secured their 2<sup>nd</sup> sponsor and in the process of finalizing contract terms.

• Donna brought out that the Highlights featured an article about the Road Rangers with an illustrative cover photo with the faces of some of the Road Rangers.

• FHP Trooper of the Year was Trooper Danyen Komorek, who is part of our TIM team. She was also Trooper of the Month in April.

• NUG Webinar will be after meeting in the Acosta room and welcomed all to attend. 




