Alachua TIM Team Meeting Wednesday August 10, 2011

Meeting Minutes





- Donna Danson opened the meeting by welcoming everyone and asking everyone to introduce themselves.
- Donna then stated the purpose of the meeting, which is to come together as a group to help each other grow and ensure that lines of communications are kept up.
- Donna stated she had not received any corrections for the last set of meeting minutes, so as of now they are approved. She had a copy with her if anyone wanted to review them.
- Ed Ward gave the EOC update
 - There will be a Local Emergency Planning Council meeting on August 11th in Belle, Florida at the Florida Gas Transmission Office. The group is out of Gainesville and covers 11 counties.
 - Tax free shopping weekend starts Friday.
 - There will be a meeting for the Department of Emergency Management Region 3 in September. Anyone wanting to attend can contact Ed for more information.
 - There is a Homeland Security meeting at the FDLE complex in Jacksonville on September 14th. Anyone wanting to attend needs to contact Ed to get clearance prior to the event.
 - There are currently no tropical storms or tropical depressions, but a tropical wave is coming off of Africa that may turn into a tropical storm.
 - Pasco County and other areas to the south are currently experiencing flooding due to heavy rains yesterday.
- Chris Dolan was not present to give the City of Gainesville TMC update
- Craig Carnes provided the ITS Update.
 - The Governor and Secretary of Transportation had mentioned funding for Future Transportation Projects in a news conference last week. They have stated capacity projects

will be put on hold or will be built as public/private partnerships. Funding will be increased for Transportation Systems Management and Operations (TSM&O) projects. TSM&O uses technology and interagency coordination to improve traffic flow on congested roadways. Some examples of TSM&O type projects that may be applicable for Gainesville would be upgraded signal controllers, installation of ITS devices, and communications projects to connect various agencies into a single network.

- In an announcement last week, vehicle manufacturers stated that in 3 to 5 years all cars would be equipped with the technology to communicate with each other and roadside devices. This will enable the use of accident avoidance systems, real time traffic, weather information and many more uses.
- ITS World Congress will be held October 16-20 in Orlando. Anyone that wants to attend to see exhibits such as automated vehicles and the latest in ITS Technology, please contact Pete Vega for more information.
- Pete is working with Central Office to get approval to use the FDOT towers around Gainesville to mount wireless devices. Pete is working with Matt Weisman with the City Of Gainesville to have CCTVs mounted at major interchanges on I-75 around Gainesville. These CCTVs will use the wireless antennas on the towers to feed the video back to the Gainesville TMC.

Santos Morin gave the 511 Update

- Santos stated the newest thing out is an iPhone app for 511, with a Droid and IPad release coming soon. The app works by GPS to give you reports of incidents/congestion within a radius that you choose. The app is free on the I-Phone app store. There will be a version available for Droid in December of this year.
- Laurie Windham sent Donna the Construction updates as both she and Gina were not able to attend.
 - The I-75 project at Newberry Road continues despite the large amount of rain we have been seeing. The reduction in speed on the Interstate and the lifting of the truck restrictions seem to be helping and traffic seems to be adjusting.
 - State Road 26 Overpass at US 301 is close to completion. The friction course has been placed and it looks like the project is beginning to wrap up. There will be another project to correct some sight distance issues and Laurie will let the team know as soon as there is a schedule.
 - Laurie wanted Donna to pass along her thanks to the entire team for their help in getting the first Alachua County TIM Team Newsletter organized, developed and distributed.

Next the Team went over Incident Debriefs

- Bruce Strickland and Alan Martin discussed the July 27th accident on I-75 NB at MM 379 where the van overturned. When the one vehicle overturned it took out a large section of fencing. FDOT Maintenance was not made aware of this and did not find out about it until Alan noticed it the next day. FDOT Maintenance needs to be made aware any time there is damage to FDOT property.
- The oak tree that fell across SR 121 on July 26th closed down the entire roadway for several hours. The tree was so large that it took FDOT crews two days to remove all of the wood from beside of the road.
- The Division of Forestry was not giving advanced notice to place smoke warning signs on the roadside, they were instead waiting for off duty hours for notification. Bruce has corrected this issue.
