### Alachua TIM Team Meeting Wednesday, February 9, 2011

#### Meeting Minutes

For the list of attendees, please see the attached sign in sheet.

- Pete Vega opened the meeting by welcoming everyone and asking everyone to introduce themselves.
- Pete then stated the purpose of the meeting, which is to come together as a group to enhance communications and discuss our successes and areas of improvement for Traffic Incident Management.
- Pete stated that Donna Danson had previously distributed the meeting minutes and asked if there were any changes or comments. There were none, so as of now they are approved.
- Ed Ward provided updates within the EOC.
  - There is a Child Abduction Exercise going on now that could affect traffic. Signs are put up to let the public know that it is just an exercise so as not to cause panic due to law enforcement coming on and off the roadway with their lights on.
  - Sometime this spring the Homeland Security Committee will be directing another exercise in Camp Blanding, similar to one they did last year. EOC would like to get involved by providing portable cameras.
  - Pete asked if the Hurricane Conference would be taking place anytime soon. Ed stated that he wasn't sure if state employees would be able to go given the new governor and the new agency head status. Ed did mention that he and his counterparts in each district just recently attended the annual Florida Emergency Preparedness Association Meeting and are learning how to use the TIME software.
  - Ed explained a statewide study he has been a part of for the past 4 years that does regional evacuation studies, which gives information to the counties so the counties can then update their evacuation plans.
- There was not a representative for the City of Gainesville so Pete Vega gave an update.
  - Pete mentioned the new TMC and the availability of video to team members. The TMC has newer technology such as computerized monitors for the video wall and the ability to dynamically control the traffic lights.
  - Peter mentioned that Matt Weismann has been working on travel time for the arterial roads as well as adding smaller signs on the arterial roadway with the money left over from the new TMC.
  - They have wanted to add travel time capabilities, arterial DMS, and CCTVs at interchanges so they can tap wirelessly into their network and have the cameras monitoring the interstate and use flashing beacons to alert motorists of anything going on.

- Pete Vega provided an update of RISC.
  - Pete stated that we have not had any risk events anywhere in the state of Florida in awhile. He mentioned that they are still trying to convince central office of the need to use RISC in an event where it could be helpful, even if it is not on the interstate.
- Pete Vega provided an update of 511.
  - 511 in the city is a growing market and that the next step would be to get the University involved in doing research projects that can tell us how much of a benefit it is and if we should continue to use it.
  - Will hopefully begin 511 in Gainesville soon.
  - Pete explained that for 511 there is a TMC Operator dedicated to monitoring the FHP CAD as well as software that gives them travel time information on the interstate. He explained that he tracks the reports every month for the Gainesville area. It takes an average of 7 to 10 minutes from the time an incident is reported to when steps are taken to deal with the incident. Pete believes this time could be much better because at 10 minutes there is usually a mile backup of traffic. He encouraged everyone to call \*FHP or \*347 if they hear of an incident to make sure that the TMC is aware of it so they can get the ball rolling sooner if they have not been informed of the incident.
- Laurie Windham provided an update for construction.
  - Laurie mentioned the addition of another turn lane off of the Northbound I-75 off ramp onto Newberry Road. The official start date is March 28. She is working on an open house for the general public in that area towards the middle of March at the La Quinta Inn, and that there will be a separate open house for the hospital. Laurie stated that the project would be shut down between Thanksgiving and New Years. The Project Manger is Sandy Chitwood.
  - There is work being done in medians on the drainage at US 301 from Waldo up to Orange Heights and will be looking at paving the friction course in the next few weeks. There is not much impact expected since it is a 4 lane road and only one lane at a time will be done.
  - The overpass at SR 26 over 301 will have the bridge open on December 17. Laurie mentioned that there has been some complaints due to the bumpy areas but that it is only temporary asphalt and within the next few weeks the pavement and asphalt portion should be finished.
  - The Archer Road median project has run into several challenges due to the weather. There will not be any daytime lane closures.
  - Laurie provided attendees with updates, detour routes, and parking schematics (see attachments) for Main Street. On Wednesday construction will be moving from SE 2<sup>nd</sup> to SE 1<sup>st</sup> Avenue.
- Bruce Strickland and Team Members provided an Incident Debrief.
  - Ed Ward provided an Incident List for the attendees (see attached).
  - There are fence cuts on I-75 that FDOT were not aware of and can cause issues especially if livestock are present. Bruce mentioned that they do routinely patrol the fence lines on the interstate to keep it up to date. Pete stated that he would contact the division of Forestry, Alachua Fire, etc. regarding the fence cuts and who to contact.

- Bruce mentioned that an accident at US 301 and SR 20 between a semi and pick up caused FDOT Maintenance quite a bit of confusion because FHP and ASO had conflicting requests. One for MOT (FHP), and one saying MOT was not needed (ASO). Bruce had his crew go with FHP's request and they did set up MOT at the accident scene.
- Announcements from Pete Vega.
  - The ITS World Congress will be held on October 16-20, 2011 in Orlando. Pete mentioned that it would go over a lot of aspects of incident management as well as next generation technology. The website is <u>www.itsworldcongress.org</u> and attendees can register for the conference, technical sessions, and special events.
  - The next Alachua TIM Meeting will be April 13, 2011. Pete asked everyone to think about the idea of starting to have a newsletter produced every month, bi-monthly, quarterly, etc.




VISION: Through cooperation, communication and training the Teams intend to reduce incident scene clearance times by 10% Each year through 2015.

# MAIN STREET UPDATE February 2011

Main Street, between Depot Avenue and North Eighth Avenue, is being reconstructed into a two-lane road with a center turn lane, bicycle lanes, bus bays and on-street parking. Underground utilities and traffic signals are also being upgraded.

The base of the road between North Eighth Avenue and North First Street was completed and reopened in May 2009. Construction south of University Avenue began in sections, starting at the intersection of Depot Avenue and heading north, in January 2010. Work on the current section at South Second Avenue is now nearing completion, and the intersection will reopen when construction moves to the next section.
