First Coast TIM Meeting Tuesday, March 15, 2011

Meeting Minutes

The list of meeting attendees and the Meeting Agenda are attached to these meeting minutes.

- o Donna Danson welcomed everyone.
- Donna stated the purpose for these meetings is to discuss crashes/incidents that have happened over the last couple of months and see if there is anyway we can improve and help each other.
- Meeting minutes from the January TIM meeting were approved.
- Mike Goldman gave the construction update.
 - Sound walls are to be installed at Lem Turner and Edgewood on I-95.
 - I-295 Collins Rd. Collector distributor should have minimal traffic impact, 2 lanes are being added in each direction.
 - Pavement rehab has been scheduled from Atlantic Blvd. to JTB. The first part of this job is the sound wall on both sides. The pavement work should start in August or September.
- Donna asked the team members in attendance to introduce themselves.
 Please see attached sign in sheet.
- Ed Ward gave the Emergency operations update.
 - The wildfires that occurred a few weeks ago have been the only issue. They caused separate road closures and some locations are still dealing with the ramifications such as smoke on the roadway.
 - Donna asked Ed if he had heard of any predictions for the rest of fire season and he has not as of yet.
 - Ed mentioned that a few gentlemen from the Emergency Operations Center in Tallahassee's Central Office would like to come down and tour FDOT's TMC on March 24th. Pete Vega said that this would be fine.
 - Pete mentioned that hurricane season is coming up and asked when the predictions would be put up. Ed explained that the predictions are usually announced the first of April. Pete also asked if a Hurricane Conference would be held this year. Ed stated there is one held in May although state employees likely won't attend unless they are teaching a class.

- Pete explained the I-95 Corridor Coalition, STIX. This organization covers almost the entire east coast and obtains information from any of the districts whenever there is a roadway closure on a North/South interstate. This information travels all the way up to New England and is accessible through 511 in hopes it will either deter travelers or reroute them so as not to cause traffic congestion on our roadways.
- Patrick Odom spoke on behalf of the Central Office.
 - FDOT is still involved in the Road Ranger Incident Responder Survey and asked everyone to participate in the survey if they haven't already. It is an online survey but Donna mentioned she has paper copies available. There have been roughly 500 responses statewide so far with a lot of good feedback. The survey will be terminated at the end of March and then they will be processed followed by a report.
 - The Road Ranger Procedure Review is coming up. (There is a review every two years.)
 - Pete asked Patrick if anyone has heard anything about Road Ranger program funding in any legislative sessions. Patrick stated Mark Wilson and Brian are watching it closely but haven't heard anything so far.
- Pete Vega gave the ITS Update.
 - Phase 6 was completed this past summer. Phase 6 was at the south end of Jacksonville, at the 295 interchange, into St. Johns County.
 FDOT and consultant personnel are currently working with St. Johns County at CR 210 to try and tie in cameras at a really bad section in that area where traffic tends to accumulate and eventually back up. The information can then be passed along to law enforcement. During this design review FDOT will also be looking into tying this into the St. Johns County Sheriffs Office and the FHP along SR 16.
 - Construction for Phase 7 (Atlantic Blvd. North on 9A to I-295 interchange) was supposed to start yesterday.
 - Phase 8 (I-295 from I-10 to I-95 North) will have a final decision by late April and should be a pretty straightforward project. He said that from what he has seen with Phase 7 and Phase 8, he is anticipating they will be concurrent projects which should be finished around the same time and that those devices should be utilized within a year.
 - Signs, cameras, and controllers are up and running along SR 21 in Duval and Clay Counties. The project hasn't received final accepted but will soon. Pete mentioned that once completed it will be our first experience at managing a system on an arterial roadway.
 - The project on SR 15 from Collins Rd. in Duval County south to Creighton in Clay County has been progressing well with the exception

of one sign foundation. This, along with the SR 21 project, will help us provide information to the commuters traveling in that area of the District.

- In Duval County, Atlantic Blvd and Beach Blvd have advanced and are waiting on interconnection to provide a direct link. The US 1 project on Phillips Hwy should start work on April 1st. Duval County should have a pretty good system within the next year.
- Cameras are up and traffic controllers have been upgraded along SR 200 between I-295 and the Intercoastal in Nassau County. FDOT is looking for a way to tweak the system to make it more useful. This should help provide a way to get camera images to JRCC within the next 6 months. There is also a project to put cameras on the Fernandina side so camera images will be available as well as access to signal information from east of Fernandina all the way into I-95. This project will hopefully be finished by January.
- The RWIS specs for mounting wind sensors on all of the tall bridges in NE Florida are almost done.
- He stated the NFTPO will have to change their method of rating the roads in the next few years. They currently use an A, B, C, etc. grading system and will have to convert to actual numbers such as travel times, speeds, etc. Bluetooth technology is being considered to get these numbers instead of the products the FDOT currently uses. The product used by the FDOT is very expensive and takes 2 days to install, whereas Bluetooth technology is about a third of the cost and only takes 15 minutes to install. Bluetooth technology in this application does not invade privacy. It also has a filtering system that throws out bad data.
- The ITS Department has been working with Central Office on a video aggregation system for 511 that would give streaming video instead of the current snapshots. This project has been put on hold until Florida's new administration has settled in.
- The inauguration of the new smart phone application occurred this week. SPARR (Smart Phone Apparatus for Road Rangers) went live today and will reduce radio traffic and paper work for the Road Rangers.
- The NFTPO and HNTB are doing a study on locations for ADMS
 - Arterial Dynamic Message Signs in the COJ. FDOT has been given \$1.25 million to develop this project.
- Greg Gaylord gave the Road Ranger update.
 - The Road Rangers are learning how to use the SPARR application and it is a very robust and solid tool.
 - First Coast Road Rangers have a sponsorship agreement in place at the moment. The website to access this information and the sponsorship banner is <u>www.firstcoastroadrangers.com</u>. Greg has already received a number of responses in the few weeks the site has been up.

- There are no incidents to report.
- Road Rangers assisted a Greyhound bus that broke down carrying 52 people during the wildfires. Road Rangers were able to keep the bus line's corporate offices updated on the status of this bus and the safety of the passengers with the help of 511.
- Pete added in the event of a fire or accident, Road Rangers could be dispatched to use their message boards in locations without any DMS signs to alert motorists to call 511.
- Pete also added that although SPARR is simple now, it has room for advancement. For example, eventually Road Rangers could take photos and video that would help FHP and EMS know how many units to send out.
- Donna provided 511 Feedback.
 - Donna read a comment left on 511 from a motorist who was upset that all lanes were stopped due to an accident on 2/26/11 at 5:58pm on I-95NB at exit 318. The motorist suggested that FHP open at least 1 to 2 lanes to avoid this amount of traffic buildup.
- Craig Carnes provided an Incident Debrief.
 - Craig asked everyone to review the Incident Debrief list from Ed Ward.
 - ^o Crashes on January 20th
 - Overturned RV just North of SR 16
 - Secondary crash near CR 210
 - Greg Gaylord stated that RISC would not have expedited things because they would have had to wait on the Fire Department anyway.
 - Pete stated that he would rather RISC be activated rather than not. FHP should not worry about activating it and then not needing it. It is better to err on the side of expediting the opening of the roadway.
 - o Crash on February 24th
 - Overturned lumber truck
 - Lumber had to be loaded by hand due to the length of the lumber and how much it had been damaged.
 - Pete asked Michelle Sanders if inmates could be used for TIM service for incidents like this where it has to be handled manually. Michelle will follow up by checking with FDOT Maintenance.
 - Craig presented the Performance Measures data in a PowerPoint presentation.

- Final Announcements
 - Everyone was reminded to participate in the Road Ranger survey mentioned at the beginning of the meeting.
 - The next TIM meeting is scheduled for March 15, 2011 and meetings are held every other month.
 - Coming soon will be a JFRD Presentation of their webEOC by Elizabeth Henderson.
 - Kenton Brown retired on 1/31/11.
 - There is now a TMC in District 3 (Pensacola).
 - We have the ability to get video images from Orlando and may be able to connect with Miami before hurricane season.
