


First Coast TIM Meeting Tuesday, September 18th, 2012

Meeting Minutes



The list of meeting attendees and the Meeting Agenda are attached to these meeting minutes.

- Donna Danson welcomed everyone.
- Donna stated the purpose for this meeting was to discuss accidents/incidents, which have occurred over the last few months and to see if there is anyway we can improve and help each other.
- Meeting minutes from the July 2012 TIM meeting were approved. They will be posted on Jax511.com
- Mike Goldman provided the Construction Project update.
 - The weather has been an issue with paving jobs, especially on I-10. All Westbound lanes should be open by October 1st and Eastbound lanes by October 5th, weather permitting.
 - The barrier wall project on the Dames Point Bridge should be finished by the end of the year.
 - The Overland Bridge Project should start at the beginning of next year. This project will involve a lot of MOT and traffic shifts.
 - The Marietta Interchange Project should start in December or January. This will be the third phase of the I-10 and SR 23 corridor project.

- Ed Ward provided the EOC Update.
 - There are still claims being filed from Tropical Storm Debby. The Governor's executive order expires tomorrow.
 - Penny Kamish asked for a list of the D2, D3, and County EOCs. Ed will provide.
- Pete Vega provided the ITS Update.
 - The Phase 7 Project, SR 9A/I-295 northeast quadrant, is under construction once again. The surety company took over and hired American Lighting and Signalization to complete the project.
 - The Phase 8 Project, I-295 northwest quadrant, is continuing to make progress and the contractor plans to begin testing devices in the next 20 days.
 - The Phase 9 Project, SR 9A/I-295 southeast quadrant, should be awarded in October and construction should begin in early 2013.
 - The Phillips Hwy Project should be ready for testing in about 2 weeks.
 - The Arterial Dynamic Message Sign Project was awarded to Traffic Control Devices and they have ordered the signs. This project consists of placing small Dynamic Message Signs on Baymeadows Road, Emerson Street, and University Boulevard to be able to divert traffic off of I-95 as well as aiding in detouring for maintenance and construction projects.
 - The JaxPort Project design is 60% complete. This project along with deployed BlueTOAD devices will allow for monitoring of freight traffic.
 - The Department of Management Services is helping with the RTMC Project. They are in the process of selecting an Architect and hope to break ground by next fall.
 - The SR 23 Toll Road Project has been advertised for a Design Build team. This project will include ITS along the corridor which will basically tie into Orange Park to help divert traffic.
 - 3 Express Lanes Projects have been proposed using Miami as an example. The proposal is to have 2 lanes in each direction with an optional toll lane. The proposed locations are:
 - I-295 between the Buckman Bridge and I-95
 - I-295 East Beltway between Butler Blvd. and SR 9B
 - I-295 East Beltway between I-95 and Dames Point Bridge
 - Robert Opland, with JTA, asked how the Wind Sensors were working and Pete replied that they are doing very well. They were recently tested for accuracy with an anemometer and came within a mile per hour or two difference. This could be from human error or the location. There will be continued research with the National Weather Service to improve accuracy.
 - There are 6 BlueTOADs being deployed along SR 200.
 - All maintenance related items for FDOT should be directed to the TMC at (904) 359-6842. A TMC operator will take the information and then call the Asset Maintenance Contractor.
- Donna provided the Road Ranger Update
 - Donna asked that everyone observe a moment of silence for Terry McCart from Southern Wrecker who passed away in an accident.
 - The Road Rangers are still trying to secure more sponsors.

- Donna opened the floor to any agencies that had anything they would like to add or address.
 - FHP Captain Gaston mentioned FHP has taken over responsibility for accident investigations on all State Roads and that 4 FHP Trooper positions will be added in November.
 - Captain Gaston would like to present the Signal 4 Analytics Software at the next meeting. Donna will work with Captain Gaston to get this arranged.
- Jill Dawson provided an incident debrief and summary of performance measures.
- A question was asked in regards to the Asset Maintenance Contractors and which roadways they are responsible for maintaining.
 - Duval County Primary Roads – DBI
 - Duval County Interstates – Transfield
 - Clay & Nassau Primary Roads – Jorgenson
- Jason Summerfield provided a demonstration of the capabilities and features of the new TMC Video Wall Software Activu.
- Craig Carnes provided a presentation on the new but not yet released TIM Team website. The website will be released on or before October 15th.
- Announcements
 - Donna mentioned the Arizona TIM Team members peer-to-peer trip. She thanked everyone who participated in their visit.
 - Donna announced our next meeting would normally be held on November 20, 2012 but considering it is the week of Thanksgiving she asked that anyone who would need to reschedule due to holiday conflicts to please contact her.
 - Donna stated the TIM Team received a score of 94.2% from the FHWA Team Assessment.
 - Craig passed out a Memorandum of Understanding to each of the TIM Team member's agencies/departments.
