## First Coast TIM Meeting Tuesday, May 21, 2013

#### **Meeting Minutes**





The list of meeting attendees and the Meeting Agenda are attached to these meeting minutes.

- Donna Danson welcomed everyone and thanked FHP for hosting this meeting.
- Donna stated the purpose of this meeting is to debrief recent incidents to work together to find out how to assist each other and make things better.
- Attendees introduced themselves to the group.
- There were no comments on the March 19, 2013 First Coast TIM Team Meeting Minutes so they are approved as read.
- An update on the Overland Bridge Project was given by Bill Kays of KCCS
  - They are currently in the middle of a traffic switch, which will move traffic to the west. A new traffic pattern will begin at the Acosta Bridge after Memorial Day. The eastern side of the bridge will be demolished at that time.
  - Motorists are being notified with portable message boards and shields painted on the roadways. Some overhead signs that indicated the old traffic pattern have been removed.
  - Pete suggested posting information about the upcoming traffic shift on the dynamic message signs. Bill will get with Ryan Crist to coordinate.
- Mike Goldman could not attend, so Donna gave the Construction Project update
  - Though Mike Goldman was not able to be present he relayed that there is nothing new going on, but if anyone had questions or concerns they could contact him.

- Ed Ward could not attend, so Donna provided the EOC update
  - Ed has been doing several activities in regard to hurricane preparation including attending the Governor's Hurricane Conference.
  - Ed will do a presentation at the July meeting about hurricane preparedness.
- Pete Vega provided the ITS Update.
  - Deployment of Phase 8 on the northwest quadrant of I-295 is complete and the project is currently in the maintenance phase.
  - Phase 9 on the northeast quadrant of I-295 will probably be ready to use in August. This project is critical in monitoring crashes and averting secondary crashes near the Port.
  - A project is currently under construction with Hinson Electric to install new CCTVs and MVDS at the I-10 interchange, which will improve coverage despite the obstructions from bridges and ramps.
  - The attorney expects a resolution by June on the Phase 9 project on the southeast quadrant of I-295. This is the final interstate project expected for a while, so it will include evacuation routes, signs on arterials, and DMS on JTB.
  - There are a few ITS projects on the table for interstates leaving Jacksonville. Some possible projects for full ITS deployment would be on I-95 from Pecan Park Road to the Georgia State Line, I-95 from CR-210 to US-1 in St Johns County, and also I-10 from SR 23 to US 301 or further.
  - The project on I-75 from Marion County to north of Paynes Prairie/SR 24 will be let in September. There are also follow-up projects on I-75 from SR 24 to the City of Alachua and a candidate project from the City of Alachua to the Georgia State line.
  - A project was recently Let to run fiber optic cable to connect JaxPort facilities to the FDOT fiber optic cable to allow for coordination between JaxPort and FDOT.
  - The Airport Road Project, which is installing fiber optic cable from I-95 along Airport Road, is almost complete. This installation will allow for FDOT and Jacksonville International Airport to have access to each other's' information and videos.
  - The Arterial DMS (ADMS) Project is about a month away from completion. This
    project is installing ADMS on arterial roadways in the area south of the Overland
    Bridge.
  - The Regional Transportation Management Center Project is in the process of finalizing design. It will be a 25,000 square feet single story building housing the TMC, FHP, City Signals, JSO, JFRD and the TPO. Having multiple agencies in one location will improve communication between agencies. Construction is expected to begin in August and it will take about 12 months to complete.

- Pete Vega gave the 511/TMC update.
  - There have been problems with the 511 System over the past two weeks. The phone and app seem to be the least reliable, but the website appears to be working well.
- Greg Gaylord provided the Road Ranger Update.
  - A new contract is in place. There are about 4 sponsors in line to come on board. Also, there have been no incidents involving Road Rangers lately.
- Donna Danson asked for Agency Reviews.
  - No agencies had any comments
- Incident Debrief
  - Don Mozick of FDEP reminded everyone to please call the State Watch office ASAP when they may be needed. He stated that for the incident on 4/4/13 on I-95 at Lem Turner, SWS was not called for quite a while.
  - Ryan Crist emphasized the need for communication. He reminded the group to make sure the duty officer/call taker clearly understands the location, otherwise response will be delayed.
- Diana Rivas presented the performance measures for the last few months and reviewed some recent major events.
  - o Diana debriefed performance measures for the last few months.
  - She discussed an incident, which occurred on April 25<sup>th</sup> on I-95 at MM 330. It involved a semi-truck that caught fire off of the roadway. All lanes were blocked.
  - The group discussed an incident that occurred on April 27<sup>th</sup> on I-95 SB at MM 302. It lasted several hours between Saturday and Sunday. There was a fuel spill and the contents of the trucks were spilled onto the roadway which included a chemical with a low flash point. The group discussed the incident in detail and it was seen that there is a need for improved communication. Per Captain Gaston, Captain Cruz plans to meet with St Johns County Fire Rescue personnel in regard to issues raised with this incident since the department was not present at this meeting.
  - Diana gave a brief overview of the location of crashes in Northeast Florida on May 3<sup>rd</sup> when there was heavy rain. There were 68 crashes identified on interstates in the area that day. Pete stated there are typically more accidents on rainy days and solicited the group to submit ideas to him for reducing crashes due to rain.
- Captain Keith Gaston presented a brief tutorial on using the Signal 4 Analytics Software. Anyone who would like a username and password to access the software can contact Captain Keith Gaston. He also showed the public FHP website that shows current traffic incidents in the area. The URL is <u>http://www.flhsmv.gov/fhp/traffic/crs\_h718.htm</u>.

- Announcements were made by Donna Danson and other TIM members throughout the TIM meeting.
  - The next First Coast TIM meeting will be held July 16, 2013.
  - Keith Gaston relayed that when he was at a Senate committee meeting about reauthorization for the MAP 21 project Pete was praised for the work he has done with the BlueTOAD devices.
  - Richard Reid, with St. Johns County Traffic, announced that he will be retiring so this is likely the last TIM meeting he will attend. There is a retirement party for him next Wednesday.
  - Pete announced there would be a Table Top exercise about one-way evacuation routes on I-75 and I-10 this Thursday.
  - A SHRP II Train the Trainers workshop is scheduled for June 17<sup>th</sup> and 18<sup>th</sup>. Pete Vega will be sending out more information tomorrow morning.
