Alachua/Bradford TIM Team Meeting Wednesday June 11, 2014

Meeting Minutes





- Donna Danson opened the meeting by welcoming everyone and stated the purpose of the meeting is to work together as a team and learn from each other.
- Donna then asked everyone to introduce themselves. She also introduced Josh Reichert, the new District Two ITS Program Supervisor. The sign-in sheet is attached to these Meeting Minutes.
- Following introductions, Donna stated she had not received any corrections for the last set of Meeting Minutes, so as of now they are approved.
- Ed Ward provided the EOC Update
 - Not much going on other than a lot of rain.
 - Ed mentioned that he has been updating the Continuity of Operations Plan (COOP).
 - The Hurricane Conference was held last month in Orlando. Dr. Grey predicted 9 named storms, 3 hurricanes and 1 major hurricane.
 - Josh described the service patrol, heavy wrecker, van transport, and fuel supply contracts that have been developed to improve the flow of traffic in the event of an evacuation.
- Gina Busscher gave the Construction Project Update.
 - There has been Railroad work with closures on US 301. The project should be complete and reopened today if there is no rain.
 - Rebecca White mentioned the railroad crossing replacement on SR 121 went smoothly as well.
 - The I-75 and US 441 Interchange Project is now 50% completed and should be completed by winter 2015.
 - The I-75 ITS Project is in the trenching stage and is up to Paynes Prairie and should be completed by winter 2015 as well.
 - The first phase of the US 441 Resurfacing Project is almost compete.
 - o There are 2 new upcoming Sidewalk Projects:
 - NE 177th Pl. & Waldo

- Craig Carnes gave the ITS/511 Update.
 - There is discussion from Central Office on moving the DMS on US 441 southbound before Paynes Prairie back a mile towards SR 121 on the I-75 Project.
 - Metric Engineering won the design for the I-75 Project in Alachua County north to the Georgia State line. There will be 2 different phases, one this year for the entire conduit infrastructure, and the other next year to put in the devices, power services, etc.
- Donna led the Agency Reviews.
 - o FHP
 - > FHP mentioned that Captain Fincher has been having health issues but is getting better and will hopefully be back soon.
 - Major Spalding has transferred to Troop G from Troop B. Captain Powell is said to be promoted to take Major Spalding's position.
 - ➤ The second part of "Staying Alive on I-75" is on June 27th-29th and will be stressing the public to move over for responders.
 - o GPD Not present.
 - Medical Examiner Nothing to discuss.
 - o FDOT Maintenance Nothing to discuss.
 - DBI / Asset Management Nothing to discuss.
 - Alachua County Fire Department
 - ➤ There will be a large multi-agency training drill at the Oaks Mall on June 22nd from 7-11 a.m.
 - Emergency Management
 - > Brian Johns led a discussion on the procedures taken for calling the State Watch Office and the FDOT being involved in the notification process.
 - Wrecker Association
 - An event called "Touch a Truck" was held last month which included various organizations including highway patrol and the fire department. It was very well received by the public.
 - Division of Forestry
 - ➤ Jamie Rittenhouse gave a report for Alachua and Bradford Counties. Since the last meeting there have been 2 wildfires in Alachua County which burned 0.6 acres, 940 authorized burn piles, and 497 authorized fires for a total of 2,573 acres. There have not been any wildfires in Bradford County since the last meeting. There have been 137 authorized burn piles, and 50 authorized fires for a total of 13 acres.
 - FDEP-BER / Alachua Environmental
 - Chris Gilbert stated the accident on April 15th on I-75 resulted in diesel on the Interstate. FHP asked the Micanopy Fire Rescue to wash down the Interstate, which is unacceptable and resulted in a larger clean up to clean the soil instead of just the Interstate lanes.
- Donna led the Incident Debrief.
 - The incident list is attached to these Meeting Minutes.
 - The incident on June 2nd on US 301 and CR 1474 was discussed at length. Chris discussed issues of whether or not the train was carrying hazardous materials. BJ Hock noted that the lane was closed for safety due to the media and onlookers.
- Craig Carnes provided an update on the SHRP II Incident Management Training Course.

- Donna mentioned a nationwide training update with the FHWA she attended where it was stated that Florida is 5th in how many people have been trained.
- If anyone is interested in the SHRP II Incident Management Training Course please see Craig. He stated he will work with any agencies' schedules, including nights and weekends to make the training course available.

Jorgensen Contract Services, LLC. ("JCS" or "Jorgensen") presently performs the Asset Maintenance Contract—Bradford County (Contract ID: E2R43) for the Florida Department of Transportation (FDOT). Jorgensen's 24/7/365 responsibility on the roadway began at 12:00 a.m., January 1st, 2014 and will continue on a 7-year term. In addition to routine maintenance activities, the scope of work for this project includes operational traffic incident management on approximately 70 center-line miles of the Bradford County arterial state roadways (US301/SR200, SR16, SR100, SR18, SR21, SR230). As part of the contract, Jorgensen shall manage and perform emergency roadway maintenance and traffic incident response. Typical incident management activities Jorgensen will perform include: initial response and mobilization to traffic incidents, temporary maintenance-of-traffic (MOT) device set-up, emergency lane closures for law enforcement/fire rescue, emergency detour routes, mobile MOT operations, debris removal, temporary sign installation for smoke/fog (requests from law enforcement only).

Typical Questions and Answers: Jorgensen Traffic Incident Management

QUESTION: Why am I receiving this document?

ANSWER: You are likely apart of the emergency response team for Bradford County and will

regularly see Jorgensen on the roadways or in relevant agency meetings.

QUESTION: Who is Jorgensen?

ANSWER: Jorgensen Contract Services, LLC., aka JCS or Jorgensen, is an Asset Maintenance

Contractor for the Florida Department of Transportation. Our services are rendered directly from the FDOT; we are a professional consultant and operational roadway

maintenance service provider.

QUESTION: What is Asset Maintenance?

ANSWER: FDOT uses an asset maintenance (AM) contract to out-source operational and

maintenance requirements of defined state roadways in Florida. AM refers to the contracting method, one, which typically includes a long term (7 year) and comprehensively covers requirements 'fence-to-fence'. In addition to roadway

maintenance, AM responsibilities also include operational responsibilities: responding to

traffic incidents and setting up lane closures, etc.

QUESTION: What is included traffic incident emergency response?

ANSWER: Traffic incidents occurring on the roadway typically require temporary cones, barricades,

traffic signal arrow-boards, and closures. Jorgensen has the responsibility to set these devices on traffic incidents occurring on state routes in Bradford County. These devices

are needed to protect emergency responders, including: Jorgensen, FHP, Law

enforcement, tow operators, HAZMAT contractors, and other parties directly involved.

QUESTION: How do I contact Jorgensen?

ANSWER: Jorgensen is required to respond 24/7/365 to requests for emergency maintenance and

traffic incident MOT response. Call (904) 778-2828 and speak to a live operator.

QUESTION: Is there a fee to call or request Jorgensen's incident management services?

ANSWER: There is no fee to request Jorgensen's emergency IM services. The Department pays

Jorgensen through an Asset Management Invoice to respond to the traffic incident

management requirements on the State routes.

QUESTION: Where does Jorgensen work?

ANSWER: Jorgensen can only respond to IM requests on the state FDOT Bradford County right-of-

way routes (US301/SR200, SR16, SR100, SR18, SR21, SR230). Jorgensen is not authorized

to perform services on local, City, or County municipal routes.

QUESTION: Is there a limit to Jorgensen's responsibility during incident management response?

ANSWER: Jorgensen is not a scene commander. During incident response, Jorgensen supports the

local Law Enforcement or agency responsible for the traffic incident scene. There are limitations to the level of services Jorgensen is authorized to perform. Contact Jorgensen directly for these IM limitations. Examples of exclusions: tow-truck/wrecker services, HAZMAT spill clean-up, bridge/structural damage repair, any law enforcement activity
