

# First Coast TIM Meeting

## Tuesday, January 27<sup>th</sup> 2015

### Meeting Minutes



The list of meeting attendees and the Meeting Agenda are attached to these meeting minutes.

- Donna Danson opened the meeting by welcoming everyone.
- Attendees introduced themselves to the group.
- Donna stated the purpose of this meeting is to help each other in order to improve incident management and communication between responder agencies.
- The November 2014 First Coast TIM Team Meeting Minutes were sent to the team and stand as approved.
- Overland Bridge Project Update – Bill Kays with KCCS provided the update.
  - The contractor has been concentrating their work efforts on getting traffic onto the northbound collector distributor in order to work on the northbound side of I-95. In order to do this they have been working around the Atlantic Boulevard, Kings Road and Philips Highway areas.
  - Bill estimates the collector distributor will be ready for traffic around mid-summer.
  - Steel girders will be installed over Atlantic Boulevard and Kings Road towards the end of February.
  - The contractor has been working around the Prudential Drive/Main Street/Acosta Road exit areas off of northbound I-95 resulting in some traffic switches on these arterial roadways.
  - They have also been working on the Prudential Drive/Main Street southbound to the collector distributor area which will result in a small traffic switch around mid-month.
  - Bill asked the attending agencies if they could help keep motorists at the speed limit of 45 mph in the previously mentioned construction areas.

- Team members were provided a pdf handout of the Overland Bridge Project once it is finished. He is going to look into getting a file of the photo that can be blown up. He will then forward it to Donna.
- Ron Tittle gave the Construction Project update.
  - There are no traffic impacts expected in St. John's County in the near future.
  - Duval County:
    - There will be a public hearing regarding the intersection of Atlantic Blvd/University Blvd on Thursday evening at the Christian Church on Atlantic Blvd.
    - There have been traffic shifts in every direction on SR 23 (First Coast Expressway).
    - FDOT has been using social media such as Twitter and Facebook to communicate with the public and alert motorists of construction which may impact traffic.
    - On January 29<sup>th</sup> & 30<sup>th</sup> from midnight to 4 a.m. on I-95 from CR 210 to Old St. Augustine Road there will be traffic pacing for installation of new sign structures. There will be more scheduled in future weeks.
    - Speeding has still been an issue on the Overland Bridge Project. Ron mentioned the congestion alerts on the DMS boards have helped. He is also hoping to get the media involved again to get the message out to motorists to be cautious.
    - The construction open house was just held for the I-95/Butler Boulevard Interchange. Major impacts on traffic are to be expected in that area once the construction starts.
    - Construction has begun on the I-295 express lanes project from the Buckman Bridge to I-95. The contractor has begun clearing trees. Noise walls will be going up once the clearing and grubbing is complete.
    - One of the continuous green lights on Roosevelt has already been changed and 2 others will be soon. These will be changed to normal traffic signals.
  - Nassau:
    - Work being done on A1A has caused some traffic delays.
  - Clay:
    - The railroad crossing on US 17 between Green Cove Springs and Palatka will be closed for several days in early February for repairs. This will primarily impact truckers as they will be detoured from US 17 to SR 21.

- Emergency Operations Update
  - Ed Ward was unable to attend but relayed that there was nothing to report.
- Josh Reichert provided the ITS Update.
  - Work is continuing on the Phase 9 Project on the southeast quadrant of I-295. This project includes Dynamic Message Signs, CCTV cameras, and Vehicle Detectors.
  - Fiber Optic conduit, cable and infrastructure are being installed along I-95 in St Johns County from CR 210 to Flagler County.

- Construction is on schedule for the RTMC project. The expected move-in date is September 2015.
- Craig Carnes mentioned the visibility project that is underway in the Payne's Prairie area of I-75 and US 441 near Gainesville.
- Craig also mentioned a project under design from SR 24 in Gainesville to the Georgia Line. This is a 2 part project; the first phase includes the entire conduit infrastructure, and the second phase includes adding the devices, power services, etc.
- The I-10 Design will be put out for advertisement in the next few weeks. This project is from SR 23 going west to Tallahassee. Once this project is concluded all of the interstate deployments within District 2 will be completed.
- A master hub was hit by a vehicle at I-295 and I-10 that caused some issues, but this is being resolved.
- Greg Gaylord provided the Road Ranger update.
  - There has been about a 20% increase in Road Ranger responses.
  - There have been no incidents involving Road Ranger operators or the vehicles.
  - Lawrence Johnson, with JSO, asked whether or not JSO dispatch can contact Road Rangers to notify them of DAV or debris. Craig replied that Road Rangers are dispatched through the TMC, so if JSO dispatch calls the TMC to notify them of such issues, the TMC can then dispatch a Road Ranger. The TMC can be reached 24/7 at (904) 359-6841 or through \*FHP.
  - Corey Phelps, with Arlington Wrecker Service, asked if the TMC can be called to dispatch a Road Ranger if they need temporary MOT due to a vehicle stopped in a lane or on the shoulder too close to a lane. Donna replied that they can call the TMC and then the decision will be made on sending a Road Ranger.
  - Donna stated that although the Arterial Safe Tow is listed on the Agenda further down, she wanted to address it now. TMC personnel have heard from JSO personnel that they did not believe that the Arterial Safe Tow Program was still in place. Donna has contacted Vicki Diaz and asked her to let all JSO Patrol Officers know that the program is still in place.
- Donna Danson asked for Agency Reviews.
  - None of the agencies had anything to discuss.
- Donna Danson provided the Incident Debrief.
  - The Team discussed and clarified how the lane closure lengths are calculated on the incident debrief. In summary, if the TMC has a SunGuide report, the closure time of any lane will be used to calculate the total length. If Ed Ward receives the information from FDOT Maintenance or another party then it is derived by the information Ed receives as to when the lane was reported to be closed and then when it was re-opened.
  - Team members discussed the incidents on the provided incident lists.
- Jill Dawson presented performance measures data for the last few months and provided further details about a few recent crashes with long duration times.

- Donna Danson gave the announcements
  - The next First Coast TIM Team Meeting is scheduled for March 17, 2015. Donna mentioned the TIM Team Meeting schedule is provided in the newsletter as well as on the TIM website.
  - Two new RISC contracts are beginning soon: one in Alachua County, as well as a new RISC contract in Jacksonville.
  - There will be a free SHRP 2 Incident Responder Course held on February 23<sup>rd</sup>, 2015 from 9am-1pm at the FDOT District 2 Urban Office Training Center. A notice will be sent out to all TIM Team contacts in the near future. 
