Introductions

- Donna Danson opened and welcomed everyone to the meeting.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all of our TIM agency partners.
- The January 19th First Coast TIM Team Meeting Minutes were sent to the Team previously and stand as approved.

Overland Bridge Project Update by Bill Kays with KCCS

- In the next 6-8 weeks, southbound I-95 traffic will be switched to the southbound collector distributor.
- Speed is still an issue in construction areas.

Construction Project Update by Ron Tittle, Public Information Office

- Ron thanked the Road Rangers for the Ride Alongs that will be covered on local news stations.
- There will be over \$1 billion in active projects going on in NE Florida including several upcoming resurfacing projects.
- The First Coast Expressway (SR 23) toll construction is progressing both northbound and southbound. This project will connect from I-10 to I-95 in St. Johns County, although this will take several years to complete all phases.
- Anticipate express lanes on I-95 near World Golf Village corridor.
- Addition of auxiliary lanes and widening has begun at I-95 at Old St. Augustine Rd.
- Construction will continue at I-95 and JTB, expect continued traffic shifts. This project should be complete by late 2017.

- I-295 West Beltway Express Lanes is ongoing and should be completed late 2016.
- Construction for counter balances on the Main St. Bridge will start in April. The bridge will be operational but expect some lane closures.
- I-95 at SR 9B should be open soon.
- The I-10 at I-95 project has been pushed back.
- Phase 3 of the I-95 at A1A project will begin soon.
- Anticipate continued construction of ITS in St. Johns County.
- Nassau County asked for FDOT to coordinate with them regarding lane closures, etc. They were not notified of the lane closure which resulted in several serious issues.

Emergency Operations Update by Ed Ward, Emergency Operations Office

- There will be a Hurricane Exercise in May after the Hurricane Conference in Camp Blanding.
- The Governor's Hurricane Conference will be held in May.
- Currently transitioning into a La Niña situation which will provide dryer conditions and increased wildfire risk.

ITS and 511 Update by Josh Reichert, ITS/TMC Program Manager

- Donna Danson will be retiring this week; she will be missed and we wish her luck.
- Matt Harbert is now the ITS Maintenance Manager at FDOT.
- A vendor has been selected to redesign the Statewide 511 website, app and phone system. The changes should be complete by late summer 2016.
- Testing and integration is almost complete for Phase 9. Operational testing should begin in the next week or so.
- On I-95 in St. Johns County the fiber trunk line is complete and construction contractors are working on installing devices. This will provide a statewide fiber communication along I-95 from Miami to Jacksonville.
- The SR 16/US 1/SR A1A project to install fiber along SR 16 to St. Johns County Public Works, then along US 1 and SR A1A to City of St. Augustine should begin any day now.
- Design of the fiber is complete for the project on I-10 to extend infrastructure from I-295 to Tallahassee. Construction should begin by September.
- Advertising has begun for a project in Nassau County on I-95 to install ITS from Pecan Park Rd. to the state line.
- The Express Lanes are expected to be operational by early 2017. Team members should anticipate marketing for SunPass.
- The current Road Ranger contract expires in June of this year. Advertisement for the new contract will begin soon.

Road Ranger Update by Greg Gaylord

- There has been an increase in debris on the roadways.
- The 2015/2016 Statewide Road Ranger Survey for Incident Responders has been created. Please fill out this survey as it helps with funding from Central Office. Please click [here](#) to access the survey. The deadline for the survey is April 8th.
- There will be an upcoming news piece on the Road Rangers on our local Channel 4 news station.
- Donna will be forwarding the comments from the Federal Government regarding the FHWA TIM Team Assessment.
