

# First Coast TIM Meeting Tuesday, September 20, 2016 Meeting Minutes

### Introductions

- Dee Dee Johnson opened and welcomed everyone to the meeting.
- The purpose of this meeting is to improve our incident clearance times and to expand coordination between all of our TIM agency partners.
- Attendees introduced themselves to the group.
- The July 19, 2016 First Coast TIM Team Meeting Minutes were sent to the Team and stand as approved.
- The Team also welcomed new member Marci Larson from the North Florida Transportation Planning Organization (NFTPO).
- Marci gave a brief overview of the role that the NFTPO plays in transportation and how public input determines the boundaries of the scope of work.

### **Overland Bridge Project Update by Bill Kays with KCCS**

- Bill provided the group with a presentation of the current Overland Bridge construction. The aerials are attached to these minutes.
- At the end of October there will be another northbound traffic switch which will require drivers to shift further left onto the new part of the FEC Railroad Bridge which is currently under construction. All drivers are expected to be traveling on the mainline by the end of the year.
- Project is expected to be completed by July 2017.

### **Emergency Operations Update by Ed Ward, Emergency Operations Office**

- Ed noted that everything has been quiet since Hurricane Hermine.
- We were very fortunate that there was only some minor flooding in our District as opposed to the panhandle.

- Mid-September is the peak of the hurricane season.
- Dames Point Bridge wind sensor is currently under repair.

### ITS Construction Update by Craig Carnes, Metric Engineering

- The I-95 Project in St. Johns County is ongoing and the devices are being tested. The completion date is set for February 2017.
- Overland Bridge ITS project progressing. Expected to be completed within the next 6 months.
- JTB ITS project progressing.
- I-295 East and West Beltway Express Lanes Projects which includes ITS and Toll Lanes are moving ahead. The I-295 West Beltway is expected to be completed next summer.
- District 2 has coverage of the entire area with ITS devices but everything should be finalized by late spring/early summer.
- SR 16 Fiber Extension Project to install fiber optic cable to connect St. Johns County to the fiber backbone on I-95. The fiber will then be installed to US 1 and to the City of St. Augustine to complete the connection.
- I-75 Device Installation project from SR 24 to GA line is ongoing.
- I-10 Fiber Optic Cable Installation project from Duval to Tallahassee will begin in November. The fiber optic cable will connect Duval to District 3.
- Ryan Crist mentioned that the color and graphic DMS on Butler around the I-295 beltway and in the southeast quadrant of the beltway. Any feedback on the signs will be appreciated.

### 511 Update by Ryan Crist, Metric Engineering

- Statewide 511 website, app and phone system launched during Labor Day weekend. There have been a lot of issues with the app. Ryan asked the TEAM to be patient with the system and that corrections are being made as quickly as possible.
- The old 511 app does not prompt the user to utilize the new app. The new app is called Florida FDOT 511.

### Road Ranger Update by Greg Gaylord

- Dee Dee commended the Road Rangers for the work they did during Hermine. They extended the hours of the Road Rangers from 4:30 A.M. to 8:00 P.M. during Hermine.
- Greg Gaylord discussed an incident where a Road Ranger truck was hit from behind, westbound on JTB, while assisting a disabled motorist who was changing a flat tire. The Road Ranger was sitting in the vehicle at the time of impact so thankfully he only suffered minor injuries. The Road Ranger truck was not as lucky.

### TIM Assessment Focus: TIM Activity Funding Presentation provided by Ryan Crist

- FHWA would like the Team to focus on the self-assessments to raise the score.
- Ryan focused on possible ways to increase funding for TIM activities.
- He also discussed how we can get more SHRP2 Trainers available to train and also highlighted the online web-based training module which can be a substitute for the 4 hour SHRP2 training course.

### Agency Event Management Presentation provided by Ryan Crist

• In future TIM meetings we encourage all of the agencies to provide a brief description of their role in TIM. Please contact Dee Dee Johnson if you would like to participate in an upcoming TIM meeting.

• Ryan gave a presentation on the capabilities of TMC Operations, ITS and Road Rangers. He also gave insight into some of the partnering agencies and how the TMC depends on their information to disseminate to the public.

#### **Open Forum**

- JSO requested a GIS file for interstate mile markers.
- Craig Carnes announced that there will be a SHRP2 Train the Trainer course in District 5 in Eustice on October 6, 2016 from 8 A.M to 5 P.M. and Orlando on October 7th, 2016 from 8 A.M. to 5 P.M.
