Introductions and TIM Updates

- Dee Dee Johnson opened the meeting and welcomed everyone.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners.
- Attendees introduced themselves to the group.
- The June 2017 Alachua/Bradford TIM Team Meeting Minutes were sent to the Team previously and stand as approved.

The Team held a moment of silence in remembrance of Sgt. William Bishop

Emergency Operations Update provided by Ed Ward

- Tropical Storm Emily did not make much of an impact in our area.
- Tropical Storm Franklin should not affect our area at all.
- FHP and FDOT held a workshop in Tallahassee last week on the Emergency Shoulder Use (ESU) Plan. The plan in our area is as follows:
 - On I-10 from US 301 to I-75 Outside lane.
 - On I-75 from the Turnpike to the Georgia line Inside lane.
- Steve Scanlan does not expect to have any issues with rumble strips in surfaced sections. The old surfaces which had pavement markers were more difficult to travel on.
- Sweeping and clearing any Disabled Vehicles will be performed before the evacuation begins.
- The ESU Plan for a Category 4 or 5 hurricane is as follows:
 - o 24-hour operation
 - o I-10 will take 4 to 6 hours to set up (not including sweeping plan).
 - o I-75 will take 3 to 4 hours to set up (not including sweeping plan).
- Dee Dee asked Ed to provide her with any updates through emails that can be forwarded to the Team.
- FEMA closed out 2004's Hurricane Francis in 2016. The files must be kept for 5 years.

ITS, 511 and RTMC Update provided by Craig Carnes, TMC Consultant Project Manager

- The I-75 project is going well. Device poles and power services are currently being installed. This project should be complete by July 2018.
- Conduit has been installed on the I-10 project from Jacksonville to Tallahassee. This project is expected to be completed considerably early.
- In the upcoming months, there will be another construction contract LET for ITS devices on I-10.
- There is a plan to install fiber from I-75 to Lake City.
- Dee Dee There will be an increase in Road Rangers in the area, as well as in Gainesville, due to studies and funding.
- Ryan Crist The FL511 contractor, IBI, is currently performing maintenance on the program.
 - The app will be moved into a voice command type prompt.

Incident Debrief – (Ed Ward's List attached)

- The Team discussed several incidents.
 - The accident on June 28th at US 301 and SR 24 involved a lumber truck.
 - The accident on July 18th at I-75 and MM 375 caused no severe damage to the bridge column. This event was well coordinated by DBi.

Hazmat Presentation by Chris Gilbert

Chris provided the Team with a presentation on Hazmat (Hazardous Materials).

RISC Presentation by Ryan Crist

Ryan provided the Team with a presentation on RISC (Rapid Incident Scene Clearance).

 A northbound semi-truck carrying aluminum beams crashed into the guardrail in the median on I-75 before overturning and spilling the beams
 I-75 SB at MM 381 at 8:48 A.M.
 - Crash involving a southbound semi-truck. The driver of the semi lost control, jackknifed and hit the median guardrail, shutting down two southbound lanes.
