Meeting Minutes

Introductions

- Dee Dee Johnson opened the meeting and welcomed everyone.
- The purpose of this meeting is to improve our incident clearance times and to expand coordination between all of our TIM agency partners.
- Attendees introduced themselves to the group.
- The November 16th, 2016 First Coast TIM Team Meeting Minutes were sent to the Team previously and receiving no comments, they stand as approved.

Overland Bridge Project Update by Bill Kays with KCCS

- There are two upcoming traffic switches. One will take place on I-95 southbound near San Marco where the weave on the right hand side will be brought farther back to the north. The second switch will take place on I-95 northbound, and will include splitting I-95 mid-stream. The weave to get onto I-95 northbound from the Atlantic Blvd. exit will be pushed back to Montana Avenue, which will provide three lanes for I-95 northbound, all others will use the downtown exits. Barrels and cones will be used to split those lanes off which may cause a challenge and confusion for drivers.
- Concern is also arising related to the Phillips on-ramp to I-95 because of the downtown exits and the time it may take to merge.
- The project is projected to be complete by September 2017, weather permitting.
- A map is being developed at the moment to provide a visual of the traffic switches. *(Update 2/9/17 – Please see map attached.)*

Construction Project Update by Ron Tittle

- Ron encouraged everyone to visit <http://nflroads.com> to find future projects and construction updates.
- Ron had the opportunity recently to meet with the media which will assist with highlighting some of the major projects such as the Overland bridge, Express Lanes, and I-95 at JTB.
- The I-95 at JTB Project is moving along and is on time for completion this summer.
- The Express Lanes Project on I-295 from I-95 to the Buckman Bridge is set to be completed this fall.

- The installation and upgrade of signage for the Express Lanes is ongoing.
- Adding the Express Lanes will help with congestion issues, although crashes and accidents are predicted to take place due to drivers making last minute driving decisions/changes.
- The Express Lanes Project on I-295 from I-95 to JTB is ongoing. This project should be completed by late 2018.
- The Hart Bridge is undergoing repairs/improvements and is projected to be completed in early 2017.
- The Dames Point Bridge is undergoing repairs and is projected to be complete in March.
- I-10 at I-295 is in the beginning stages for improvements that should be complete by Summer 2020.
- The I-10 at US 301 Interchange Project is ongoing. This is a multi-year project to improve the ingress of traffic from US 301 to eastbound I-10.

Emergency Operations Update by Sherrell Lall, Metric Engineering

- Ed Ward is currently on annual leave but passed along that work is currently being done on filing FEMA reimbursements for Hurricane Matthew and Hermine.

ITS Construction Update and 511 Update by Sherrell Lall, Metric Engineering

- I-95 Project in St. Johns County - The 90% walk through has been completed with no major issues. The contractor has been given a punch list for items to finish prior to the contract acceptance date.
- The contractor is currently installing fiber optic cable on the SR 16/US 1 Project.
- I-75 from SR 24 to the Georgia Line - The 100% walk through has been completed, the final punch list items are being addressed and no major work items remain.
- I-10 from Jacksonville to Tallahassee - The contractors are working on the installation of fiber. The work has started on the Tallahassee side of the project and is in the process of continuing to move East.
- Ryan Crist noted that the majority of the issues with the FL 511 app are currently being worked on and addressed.
- Pete Vega is attempting to obtain permission to process a purchase order to open a line of communication to certain agencies, such as video sharing etc.

Road Ranger Update by Greg Gaylord

- The construction area around the Buckman Bridge is keeping Road Rangers on their toes with the traffic changes.
- Broad Spectrum's crews have begun to bring a Truck Mounted Attenuator (TMA) with them when they are dispatched to different areas.

Performance Measures by Sherrell Lall

Sherrell provided the team with a performance measures presentation.

Incident Debrief - Ed's List by Team Members

The team members had an open discussion.

- No issues noted.

TIM Series: Agency Event Management by Greg Gaylord

- Greg gave a brief overview of the Road Rangers and Southern Wrecker organization and provided a video.

Open Forum

- Annaleasa Winter with Florida Forestry gave a forestry report.
 - The leading cause of wildfires has been lightning, with landscape debris piles being the second leading cause.
 - There are 15,605 prescribed burns currently scheduled for this year.
- Richard Davis noted that due to the fact of FHP and Road Rangers getting backed up, particularly due to inclement weather, Broad Spectrum has had to wait for a tow/wrecker service to provide a Safe Tow to relieve them. Dee Dee advised Mr. Davis to call the RTMC in these situations and ask to speak to a supervisor, as they have been given permission to request a Safe Tow.
- Mr. Davis also noted issues with debris in the roadways.
- Greg mentioned that there is a Federal update for SHRP2 Trainers. Please contact Grady Carrick for more information.
- Roger Bolman mentioned an issue with law enforcement taking a while to arrive at an accident scene.
