Introductions and TIM Updates

- Dee Dee Johnson opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve our incident clearance times and to expand coordination between all TIM agency partners.
- The May 16, 2017 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

The Team had a moment of silence in remembrance of Sgt. William Bishop.

Overland Bridge Project Update by Bill Kays with KCCS

- The I-10/I-95 Interchange Improvement Project is underway. Soil borings are being done at the Riverside Arts Market area for Design.
- It rained 19 days in June so work on the Overland Bridge was pushed back.
- The northbound I-95 traffic switch will begin the second week in August, weather permitting. The eastbound Atlantic traffic switch will follow.
- Bill presented the Team with aerial photos of northbound/southbound I-95.
- The majority of work will be complete in the fall, but some of the signs would be in conflict with the design of the I-10/I-95 Project, so the Overland design will be changed so the signs will not need to be removed.

Construction Project Update by Ron Tittle

- Ron was unable to attend, but provided Dee Dee with a presentation to be distributed to the Team.

Emergency Operations Update by Ed Ward

- Ed was unable to attend, but relayed that he is preparing for Hurricane Season.

ITS Update by Craig Carnes

- The I-10 project installing Fiber Optic Cable (FOC) from US-90 in Tallahassee to Jacksonville is ongoing. The conduit is currently being installed and FOC installation will follow. The project is moving along very well and the contractor will receive an incentive from FDOT if the project is finished by mid-October. The project was originally projected to be complete June 2018. The FOC being installed under this project will be utilized by another ITS project which will start in the fall and will install ITS devices on I-10 from US-90 to Jacksonville.
- The I-75 project installing ITS devices from SR-24 in Gainesville to the Georgia state line is ongoing. After this is finished, the entire I-75 corridor will have ITS coverage. This project should be complete July 2018.
- The I-95 ITS Project in Nassau county was just awarded and construction should start in the fall. This project will complete the I-95 portion of the fiber optic network in District 2.
- Whenever these projects are finished, all Interstates within District Two will have ITS coverage. This means that all Design and Construction Projects will need to take the ITS infrastructure and devices into consideration.

511 and RTMC Update by Ryan Crist

- 511 will have updates in the fall.
- The RTMC has been busy preparing for the upcoming First Coast Expressway, SR 23, etc.

Road Ranger Update by Greg Gaylord

- The new Road Ranger fleet vehicles are in transit from the factory.

Performance Measures by Sherrell Lall

Sherrell provided the team with a Performance Measures presentation.
