Meeting Minutes

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- There was a moment of silence held for officer Lance Whitaker.
- The purpose of this meeting is to improve our incident clearance times and to expand coordination between all TIM agency partners.
- The March 2018 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Fuller Warren Project Update by Bill Kays with KCCS

- The southbound CE is now open.
- Overhead signs and ITS sign structures are being installed.
- The majority of roadway items should be complete by mid-June.
- Southbound Philips Hwy. to the I-95 exit is open.
- The northbound collector distributor exit to Atlantic Blvd.
- All the land foundations have been installed from Park St. to Riverside Ave. to the river.
- Drainage is being installed in at the ramps outside of the FDOT building. Expected to be complete by mid-June.
- There have been some issues with the attenuator on the Forest St. ramp being hit three times so far.

Construction Project Update by Odette Struys

- Northbound I-95 at Martin Luther King Jr. Pkwy. has an outside lane closure due to a semi striking the overpass earlier this week. The incident requires emergency work to repair the structure, and the 45-day contract to repair it should start later this week.

- Matthews Bridge - Palmetto St. will be closed for the rehabilitation of a structure after Memorial Day for about 30 days.
- Express Lanes from the Buckman Bridge to I-95 - Should be complete by end of Summer/early Fall, weather permitting.
- First Coast Expressway in Clay County -
 - Phase 1 from I-10 to Blanding Blvd. should be complete in the Fall.
 - Construction for Phase 2 from Blanding Blvd. to the St. Johns River should start early 2019.
- I-295/I-95 North Interchange – Making good progress and is expected to be complete early 2021.
- Heckscher Dr. just east of Imeson Park Blvd. – Ongoing detour through May 23rd for replacement of railroad crossing surface. Traffic is being detoured using US-17 and I-295.
- Heckscher Dr. near Somers Rd. – A planned detour scheduled for May 29th through June 5th to replace railroad crossing surface. Traffic is being detoured using US-17 and I-295.
- Kingsley Ave. just west of Doctors Lake Dr. – A planned detour scheduled for June 7th through June 21st for replacement of railroad crossing surface.
- Cassat Ave. – A planned detour scheduled for May 21st between San Juan Ave. and Blanding Blvd. This detour will be overnight using San Juan Ave. and Blanding.
- Cassat Ave. – Side streets closing one at a time this week for water main installation, starting with Sunderland Rd. Traffic will be detoured to adjacent side streets.

Emergency Operations Update by Ed Ward

- Ed was unable to attend the meeting but relayed that there is nothing new to report.

ITS Update by Ryan Crist

- I-95/JTB Interchange Project – All ITS work has been completed.
- Overland Project – The contractor is working on ITS device and cabinet installation and is behind schedule. This project should be complete in a few months following integration, testing and a 30-day DMS burn-in period.
- US-90/SR 23/I-10 Interchange Project – The contractor has completed DMS testing and is preparing for testing of the other devices. This project should be complete in June.
- I-10 Phase I Fiber Project – The contractor has had significant issues with the fiber splicing and had to replace around 60,000 feet of fiber optic cable and all of the splices. This project should be completed in June.
- I-10 Phase II ITS Project – Working for an incentive bonus to get all CCTVs operational between SR 23 and I-75 before June 1st. There have been some issues related to the Phase I fiber work and electrical services.
- I-75 Phase II ITS Project – Installing final splicing and preparing for integration and final testing. This project should be complete by mid-summer.
- I-95 Nassau County ITS Project – This project is installing electrical services, device poles/structures, and devices. It is currently on schedule and should be complete late this year.
- I-295 West Beltway Express Lanes Project – This project is behind schedule. The ITS group is meeting with the CEI this afternoon to go over project issues. Estimated completion is late summer.
- I-295 East Beltway Express Lanes Project – This project is on schedule. CCTV poles have been installed as well as most DMS foundations. Contract completion is expected early 2019.

511 and RTMC Update by Ryan Crist

- The RTMC is testing a mobility feature from Activu with the Road Rangers. Ryan will be following up with Lucas from Jorgenson regarding this.

Road Ranger Expansion Update by Dee Dee Crews

- The Road Ranger program has been expanded to St. Johns County.
- Currently waiting on trucks for Gainesville and Nassau.
- Expansion expected to I-10 and I-75.
- The Road Ranger program started with 8 trucks and will now have 16 by June.

- Annaleasa Winter with Florida Forest Service
 - There have been 30 active wildfires throughout the state primarily in Central and South Florida.
 - Encouraged the Team to use the Florida Burn Tools app on their phones. There is also a new desktop dashboard tool that will inform the size of fires and if they are contained or not.
 - There are currently no authorized burns due to rain.
