## Tuesday, July 16, 2019

### Meeting Minutes

#### **Introductions and TIM Updates**

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The May 2019 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

#### **TIM Capability Maturity Self-Assessment**

- Craig led the Team in the annual TIM Self-Assessment.

#### **Overland Bridge and Your 10 & 95 Project Updates by Bill Kays with KCCS**

- There are upcoming lane closures on US 17 from 10 a.m. to 8 p.m. for drainage purposes.
- There was a traffic shift on I-10 eastbound at Stockton St. There will also be several upcoming traffic shifts in this area.
- Work is being done on the ramps in the FDOT Urban Office area.

#### **Construction Project Update by Sara Pleasants**

- There will be a planned road closure on July 21<sup>st</sup> from 8 p.m. to 5:30 a.m. on US 301 northbound and southbound. Drivers will be detoured using SR 23, SR 228, and Beaver St.

**Emergency Operations Update by Ed Ward**

- There isn't much to report at the moment.
- There was an exercise held in Jacksonville Beach regarding evacuation and re-entry to the beaches after a major storm.

**Fuel Spill Cleanup Discussion**

Richard Bame provided a presentation breaking down the guidelines and information for fuel spill cleanup.

**ITS Update/ITS Projects – 511/RTMC by Craig Carnes and Jason Evans**

- The I-75 ITS Project is complete up to the Georgia line. There is now ITS coverage from the Marion County line all the way north to the Georgia state line.
- The I-10 Project from SR 23 to Tallahassee is still under construction. CCTVs are operational from Jacksonville to I-10 and are being monitored by the RTMC. The remaining devices are being installed. These devices include CCTVs from I-75 to Tallahassee, and DMS and MVDS throughout the corridor.
- The I-95 Nassau County project has been final accepted. This project will extend ITS coverage up to the Georgia line.
- The TPAS (Truck Parking Availability System) project is progressing.
- The East Beltway Express Lanes is having additional work added to the contract, so this project schedule will be extended significantly.
- Jason Evans mentioned the TPAS system has been incorporated into the FL 511 website. This allows users to view how many parking spaces are available simply by checking online at <https://fl511.com> and then checking the "Truck Parking" box.
- The D2 RTMC is performing TMC Operations duties for the First Coast Expressway that opened on July 13<sup>th</sup>.

**Incident Debrief**

*The Team discussed the following:*

- A Team member had a question regarding the incident with a fatality on June 6<sup>th</sup> on US-17 at the Duval/Nassau County line. The incident list shows the duration of the incident as 0.7 hours, which seems like a short amount of time for a fatality. Jason will check into this.

**Performance Measures by Sherrell Lall**

- Sherrell provided the team with a Performance Measures presentation.

**Incident Review by Gerald Smith with Jorgensen**

- Gerald provided the Team with a presentation reviewing several incidents.

**Express Lanes/FCE/Road Ranger Update by Dee Dee Crews**

- The Express Lanes currently has a Road Ranger and an FHP hire-back on duty 24/7. They will remain 24/7 for the first 90 days. Once the 90 days is up, the Road Ranger's hours will change to 6 a.m. to 7 p.m. and then the FHP hire-back's coverage time will be re-evaluated and also changed.
- There is one Road Ranger on the First Coast Expressway Monday through Friday from 6:30 a.m. to 6:30 p.m.

**Open Forum**

- Dee Dee asked the Team if anyone uses Mutualink or FirstNet systems for their communications. She learned about these systems at the Statewide TIM manager meeting and is trying to find out who uses them in our area. None of the attendees was familiar with either of these items.
