First Coast TIM Team Meeting Tuesday, January 15, 2019 Meeting Minutes

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The November 2018 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Fuller Warren Project Update by Bill Kays with KCCS

- The Overland Bridge project is wrapping up with only ITS testing, lighting and signalization, and punch-list items remaining. The project is expected to be complete within the next month or so.
- The is a project in discussion to extend the drop lane between San Diego and Emerson to go all the way to Emerson. This would provide Emerson with a dedicated exit lane.
- Fuller Warren project:
 - There have been a few detours over the weekend to bring beams on to the project.
 - There is currently work being done to add bridge beams and columns to the river.
- Bill gave kudos to the Gainesville Road Rangers. He lives in the area and noted that they have been very active and are doing a great job.

Construction Project Update by Hampton Ray

- The first phase of the First Coast Expressway should be complete by Spring of 2019.
- The Express Lanes from the Buckman Bridge to I-95 should be complete Spring of 2019 as well.
- There are multiple traffic detours coming up:
 - A daily detour Monday through Friday from 7 a.m. to 6:30 p.m. westbound on Beach Blvd. at the Hart Expressway. This detour is expected to last until March.
 - There will be a detour this weekend on McCormick at St. Johns Bluff.
 - There will be a traffic switch on SR 200 in early February in Nassau County.

Emergency Operations Update by Ed Ward

- There is very little going on at the moment.
- The EOC is currently updating plans and procedures with lessons learned from Hurricanes Michael, Matthew and Irma.
- There is cause for concern for this coming weekend with the expected rain and possible freezing.

ITS Update/ITS Projects – 511/RTMC by Craig Carnes and Jason Evans

- The testing requirements and final documentation are being done for the SR 9B project, West Beltway, First Coast Expressway, as well as the Overland Bridge project.
- The I-10/SR 23/US 90 Interchange Project is complete.
- The I-75 project to install ITS devices from SR 24 to the Georgia line is in the testing phase as well.
- A project on I-10 to install devices from SR 23 to Tallahassee is underway and is expected to be complete January 2020.
- The TMC is in the process of hiring staff and providing training for upcoming projects.

- The Road Rangers are gearing up for the upcoming openings of the First Coast Expressway and the Express Lanes.

- The I-295 West Beltway Express Lanes will open in late Spring.
