Tuesday, November 19, 2019

Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The September 2019 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Your 10 & 95 Project Updates by Bill Kays

- Fuller Warren Bridge Project – The Stockton St. exit will be closed until next Summer.
- There is work being done on US 17 and the lane configuration is causing congestion.
- The sound wall is completed from the CSX bridge north to I-10.
- The work being done northbound on McDuff is currently on hold while the contractor investigates how to install the curb and gutter.

Construction Project Update by Hampton Ray

- There have been multiple detours over the last few weeks on the I-95/I-295 North reconfiguration project.
- Three lanes have been opened in both directions on the I-295 East Beltway Express Lanes.
- Construction should begin on a new Shands Bridge in 2022, this is related to the First Coast Expressway.

Emergency Operations Update by Ed Ward

- Ed was unable to attend this meeting.

Mutual Link Presentation by Craig Carnes

- Craig provided the team with a presentation explaining what Mutual Link is and its benefits.

ITS Update/ITS Projects – 511/RTMC by Craig Carnes and Jason Evans

- The I-10 Project from SR 23 to Tallahassee is under construction. CCTVs are operational from Jacksonville to I-75 and are being monitored by the RTMC. The remaining devices are being installed. These devices include CCTVs from I-75 to Tallahassee, and DMS and MVDS throughout the corridor. This project should be complete by June of next year.
- All current and upcoming roadway projects need to protect and/or relocate ITS so the designers, contractors, and CEIs need to pay attention. The ITS group is working to make sure everyone is aware at all stages of design and construction.
- Jason noted that the DIVAS (Data Integration and Video Aggregation System) will be going live soon on FL511. This will allow users to view live streams instead of just still images.

- The Buckman Bridge ATMS Project will begin soon. Construction of this project will result in the shoulders of the bridge being closed in both directions at various times. The Road Ranger routes will be altered to ensure better coverage of the bridge to better cover the bridge to be able to identify and respond to incidents faster.
- Dee Dee noted that the IVR feature of FL 511 will be phased out before hurricane season.

Incident Debrief

The Team discussed the following:

- The Team had a discussion regarding the 4 vehicle crash northbound on the Dames Point Bridge on November 5th. Two JSO undercover officers were at the scene and were trying to open the travel lanes. The Road Ranger told the undercover officers not to open the lanes because an FHP officer was in route to the scene responding the wrong way on the bridge to access the incident.
- The Team discussed the need for better communication, coordination, and cooperation

Performance Measures by Sherrell Lall

- Sherrell provided the team with a Performance Measures presentation.

Incident Review by Gerald Smith with Jorgensen

- Gerald provided the Team with a presentation, in which he reviewed an incident.

Express Lanes/FCE/Road Ranger Update by Dee Dee Crews

- The Express Lanes currently have a Road Ranger Monday through Friday from 6 a.m. to 7 p.m. The FHP hire-back's coverage time is 6 a.m. to 10 a.m., and then 3 p.m. to 7 p.m. The FHP hire-back's coverage time will most likely change once the Buckman Bridge ATMS project begins.
- The Turnpike will take over operations of the First Coast Expressway (FCE) within the next month or so. The Road Ranger for FCE will be dispatched through the Turkey Lake TMC.

Open Forum

- The 2020 TIM Team meeting schedule is now available. (*Printouts were provided during the meeting and a copy will also be attached to these minutes.*)
- Dee Dee announced that this will be Sherrell's last TIM meeting as she is relocating. She thanked her for all her hard work and help over the years.
