

# First Coast TIM Team Meeting

## Tuesday, January 21, 2020

### Meeting Minutes

*The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.*

#### **Introductions and TIM Updates**

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The November 2019 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

#### **Overland Bridge and Your 10 & 95 Project Updates by Bill Kays**

- There will be another detour on US 17 this weekend with other detours upcoming as well. The sound wall will need to be extended.
- There will be an upcoming detour on I-95 Northbound due to the first part of the Ramp T deck being poured.
- The signage for The Landing on multiple areas on I-95 Northbound will be removed.

#### **Construction Project Update by Samantha Rambean**

- A portion of the CSX bridge is being redesigned on I-10 at US 301.
- There will be a traffic shift this weekend on SR 200 in Yulee.
- Construction has begun on the DDI (Diverging Diamond Interchange) Project on San Pablo. This will have minimal impacts on traffic until this Summer.
- There will be an upcoming Access Management Meeting on January 22<sup>nd</sup> regarding proposed changes on SR 211 (St. Johns Ave./Herschel St.).

#### **Emergency Operations Update by Ed Ward**

- The Department is currently working on contracts for the upcoming Hurricane Season.
- Ed mentioned the media coverage of supplies being found in Puerto Rico that were not distributed after the hurricane.

#### **ITS Update/ITS Projects – 511/RTMC by Craig Carnes and Jason Evans**

- The I-10 Project from SR 23 to Tallahassee is still under construction. CCTVs are operational from Jacksonville to I-75 and are being monitored by the RTMC. The remaining devices are being installed. These devices include CCTVs from I-75 to Tallahassee, and DMS and MVDS throughout the corridor. This project should be complete by June of next year.
- All current and upcoming roadway projects need to protect and/or relocate ITS so the designers, contractors, and CEIs need to pay attention. The ITS group is working to make sure everyone is aware at all stages of design and construction.
- The District 2 Truck Parking Availability System (TPAS) project is ongoing and will be available to view on FL 511.

- Jason noted that the Integrated Voice Recognition (IVR) feature of FL 511 will be phased out by June 1, 2020. The IVR is the phone option for FL 511. Dee Dee mentioned the FL 511 app has voice activated and hands-free features.

### **Incident Debrief**

*The Team discussed the following:*

- Dee Dee encouraged the Team to discuss any incidents on the list.
- The Team discussed the incident on that occurred on December 6<sup>th</sup> on I-95 between US 90 and US 1. A semi-truck lost control traveling Northbound and ended up on top of the barrier wall. A skid steer excavator was required for cleanup to remove the pieces of concrete.

### **Performance Measures by Jason Evans**

- Jason provided the team with a Performance Measures presentation.

### **Incident Review Presentation by Gerald Smith**

- Gerald was working a crash on I-95 at MLK so was unable to attend the meeting. He will provide his presentation during the next First Coast TIM Team meeting.

### **Road Ranger Update/FHP Hireback by Dee Dee Crews**

- The FHP hire-back coverage in the Express Lanes ended on December 31<sup>st</sup>.
- There will be an FHP hire-back covering the Buckman Bridge area due to the construction project on the bridge. There should be at least one officer covering the area 24/7.
- Some of the Road Ranger routes have been adjusted in the areas around the Buckman Bridge. Two routes were shortened to help with any crashes on the Buckman Bridge.
- There is a possibility of having two Road Rangers overnight in the I-295 area from 6:30 p.m. to 6:30 a.m., and a possibility of having overnight Road Rangers on I-10 and on I-95. These are still in the early planning stages and not definite.
- On the weekends, there is currently one Road Ranger on I-95 and one Road Ranger on I-295. These routes might be expanded to two Road Rangers on the weekends on I-95 and on I-295, and possibly adding one Road Ranger to a weekend route on I-10. These are all in the early planning stages as well. Dee Dee noted that she will email the Team with any updates.
- The Road Rangers are currently hiring.

### **Open Forum**

- The 2020 TIM Team meeting schedule is now available. *(Printouts were provided during the meeting and a copy will also be attached to these minutes.)*
- Richard Davis expressed his concern on the need to educate people on how to merge into traffic on the interstate. This causes significant congestion and often results in accidents.
