First Coast TIM Team Meeting Tuesday, September 15, 2020 Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

*For the health and safety of everyone, this meeting was held virtually to adhere to COVID-19 safety guidelines.

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The July 2020 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Your 10 & 95 Project Updates by Bill Kays

- At the end of October, the Stockton ramp on SB I-95 to I-10 West will be opened. There will also be a new ramp opened to I-10 West and the current ramp to I-10 West will be the ramp to US 17. All of this will take place after October and through the end of the year.
- A new sound wall will be installed on Ramp K on I-10 Westbound to I-95 Southbound.
- The Fuller Warren Bridge mid span section is currently under construction and the widening sections on each side of that span are nearing completion.
- Pete Vega asked Bill what type of signing other than portable signage will be installed at the time to make sure that people aren't confused, on the wrong ramp, etc. and causing accidents. Bill stated that he was unsure at this time and he would check. Carrie Stanbridge stated that FDOT had previously discussed putting pavement marking plans on the lanes to help reduce confusion. Pete suggested that a meeting be initiated to go over what is included in the project and what the RTMC may be able to do to supplement the construction signing.
- Pete had a concern with the handrail on the Pedestrian Pathway and what may happen if a vehicle hits the handrail and possibly makes the handrail go out into the pathway. Will the pathway need to be closed until it is repaired? Craig Carnes to check with Bill and get additional information and pictures.

Construction Project Update by Hampton Ray

- I-10 Widening project from I-295 to US 17 construction has started on early works and is currently under design.
- I-10 at Yellow Water Road is currently under construction. EB is being detoured nightly for the next several days.
- Baldwin Bypass is now open to traffic on US 301 north of I-10 so that traffic can take the bypass to avoid any delays caused by trains on the tracks within the City of Baldwin.

Emergency Operations Update by Ed Ward

• Hurricane Sally discussion – the track is heading further east which means that the Florida Panhandle could see impacts from the hurricane.

- There are a lot of disturbances in the tropics that we need to keep our eyes on and the number of storms is such that it looks like we will run out of Names for Hurricanes and go to the Greek Alphabet. It would be the first time since 2005 that this has happened.
- Ed advised to stay with NOAA and the National Hurricane Center to get the best information on these storms.

ITS Update/ITS Projects/511/TMC Updates by Craig Carnes and Jason Evans

- Craig provided updates on the Truck Parking Availability System (TPAS) Project, the completion and Final Acceptance of the I-10 ITS Project, and ITS work within the I-10 Widening Project from I-295 to US 17.
- FL 511 The IVR (phone option) will still be disabled although an exact date is not known at this time. Jason stated that once the IVR is disabled, part of the phone system will still be available for emergency situations, but callers won't get up to the minute traffic information like they do now.
- Pete Vega discussed a Districtwide project to install Wrong Way Driving countermeasures on all ramps on the interstates.
- Pete also discussed adding additional CCTV cameras at all of the rest areas to be able to provide additional security and monitoring for those areas.
- Finally, Pete discussed the Data Integration and Video Aggregation System (DIVAS), which is a project by Central Office that is able to provide stakeholders and incident responders with videos of all of the CCTV cameras throughout the State.

Incident Debrief

 Carrie Stanbridge asked who made the call for the I-10 incident to have pavement replaced. Gerald, with Jorgensen, stated that when he got to the incident site that the incident was primarily over but the asphalt was in bad shape and getting worse. So, Gerald is the one that asked for the pavement to be replaced. Carrie mentioned that Maintenance should have been notified of this incident by the RTMC and asked what had happened/why they were not notified. Jason Evans stated that the incident is part of the presentation and he will have the event timeline and notes from the RTMC in the presentation so that this can be discussed.

Performance Measures by Jason Evans

- Jason provided the Team with a Performance Measures presentation.
 - Jason discussed the I-10 Eastbound crash at US 301 on July 27th and asked Carrie Stanbridge if this was the incident that she was inquiring about. Carrie stated that this was not the accident she was referring to and that the incident she was inquiring about just happened a week or so ago.
 - Pete stated that RISC was there for almost 8 hours and wanted to know why they were there so long. Jason Evans stated that RISC had been able to open up the majority of the lanes in a much shorter time but that due to the fuel spill and other items that they stayed on scene.

Incident Review Presentation by Gerald Smith

- Gerald provided the Team with an Incident Review presentation.
 - Gerald discussed the crash at SR 9B SB at Exit 4-B on Sunday September 6, 2020 which involved an overturned semi with spilled cargo and lasted approximately 10 hours and 9 minutes.

 Pete Vega asked if anyone knew the cause of the accident. Gerald stated that although the FHP report was not finalized that they believed that the semi driver was going to fast for the curve.

Road Ranger Update by Dee Dee Crews

- There have been changes to the Road Ranger schedules to make some of them 7 days/week and some 24 hours/day.
 - Dee Dee will let the Team know when the exact date is known and will send out an updated list of what the routes will be like at nighttime. The routes are as follows, but could possibly change:
 - o 2 routes on I-295
 - $\circ~$ A route on I-10 to I-75
 - A route on I-95

TIM Self-Assessment by Dee Dee Crews

 Misha sent out the Self-Assessment previously and because we are not meeting in person, we have asked if everyone could go through the form and provide their input on the scoring. FDOT will average out all of the responses and use the average scores as the Team's answers. We will be having a special meeting in October to go over the proposed scoring so that Team members can provide any additional input. We are asking that everyone provide their input by the end of September.

Open Forum

- Bill Kays stated that he had found the shop drawings for the handrail and that he would be sending those to Craig.
- Pete Vega shared the current state of FDOT's Secretary, stating that the Secretary is very
 interested in congestion related to incidents and how these incidents are cleared from the
 roadway as well as the prevention of these incidents. As previously mentioned, the
 Secretary and others do have access to DIVAS so that they can view the camera images.
 Carrie Stanbridge expanded on FDOT's focus on preventing and clearing incidents and
 stated that FDOT will have an internal meeting to go over this and invited Jason Evans to
 attend this meeting to discuss how the RTMC functions relative to emergency response
 and notification.

Announcements

- The next meeting is scheduled for November 17th at 10 a.m. Due to Covid-19, FDOT will be awaiting guidelines from the Governor to decide when to have the next in-person meeting.
