First Coast TIM Team Meeting Tuesday, November 17, 2020 Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

*For the health and safety of everyone, this meeting was held virtually to adhere to COVID-19 safety guidelines.

Introductions and TIM Updates

- Craig Carnes opened the meeting and welcomed everyone.
- Jason Evans stated the purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The September 2020 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Your 10 & 95 Project Updates by Jason Evans

- There will be lane shifts on the I-95 Southbound ramps to I-10 this evening.
- Exit 351-A (I-95 Southbound ramp to I-10 West) will be open tomorrow morning. Signage has been put up for the past few weeks alerting motorists to this upcoming change. Road Ranger routes will be extended to cover this area.

Construction Project Update

No one from the Public Information Office was in attendance, so Pete Vega gave the following updates:

- The Diverging Diamond has opened on SR 200. There has been one accident reported so far and Pete is awaiting the details.
- The East Beltway project is progressing along with a Spring timeframe to open.
- The I-295 North Interchange project will have some upcoming lane shifts.

Emergency Operations Update by Ed Ward

Ed was unable to attend, but relayed the following information:

- For the 2020 Hurricane Season, we have had 29 named storms so far. That is two more than the historic 2005 season. The 2020 Hurricane Season has also set a new record for the number of landfalls. There have been 12 landfalls so far. The old record of 10 named storm landfalls was from 1916.
- For the latest storm, Eta, District Two had no damage. There was some minor flooding and a very small amounts of vegetative debris. The 2020 Hurricane Season ends on November 30th. But, the way the entire 2020 year has been going, Ed wouldn't be surprised to see another storm after the official end of Hurricane Season.

ITS Update/ITS Projects/511/TMC Updates by Craig Carnes and Jason Evans

- Jason provided updates on the Truck Parking Availability System (TPAS) Project. This project will most likely extend out further due to a new contractor taking over.
- FL 511 The IVR (phone option) will still be disabled although an exact date is not known at this time. The app has had several updates over the past year and is more user friendly.

Incident Debrief

• Craig encouraged the Team to discuss any incidents on the Incident List. The Team had no comments.

Performance Measures by Jason Evans

• Jason provided the Team with a Performance Measures presentation.

Incident Review Presentation by Gerald Smith

- Gerald provided the Team with an Incident Review presentation.
 - The Team discussed an incident that occurred on November 2nd on I-295 East Southbound between Heckscher Dr. and Dames Point Bridge. Gerald stressed the safety aspect for his staff. Since they are placed at the end of the incident scene, they would be the first to be hit if a motorist drives over a bridge or blind spot and does not see the incident in time to stop. Pete mentioned that DMS signs will eventually be installed on the Dames Point Bridge. He said in a circumstance like this, Jorgenson could notify the TMC and they could find an officer in the area to get to the top of the bridge with their lights on. This would let motorists know to slow down until the bridge is cleared. Pete asked Jason Evans to remind him to get with Major Harris or Captain Jackson to discuss the need of blue lights in the event an incident like this should occur again.
 - The Team discussed an incident that occurred at night on November 11th on I-95 Northbound at 8th St. Jorgensen responded to a vehicle crash that was located in the left lane on the downside of a hill. Law enforcement was not on the scene, and the shoulder width at this location was not large enough to fit a vehicle. This left Jorgensen and the vehicle involved in the incident in an unsafe position. Gerald asked if a SafeTow could be utilized in a situation like this. Pete has directed the TMC to respond with a SafeTow in an event like this with unsafe conditions. He noted permission must be granted by the motorist to have their vehicle moved, and that the vehicle needs to be kept in the general area or nearest exit ramp so law enforcement can complete their investigation when they arrive.
 - Pete asked Craig to get with him about looking into a pilot project giving first responders the ability to notify a vendor/app of the incident. The vendor/app will push this information to its users to let them know they are approaching an incident. District 5 is currently looking into this, and Pete thinks District 2 could possibly participate if anyone is interested. Laura Simpson mentioned FHP has been having the same issues with safety for their personnel, so she would definitely be interested in providing input.

TIM Self-Assessment by Craig Carnes

• The TIM Self-Assessment scores have been turned in to FHWA. Once FHWA provides the scores it will be announced to the Team.

Open Forum

- Pete discussed the Wrong Way Driving system that has been installed on Lem Turner at I-95. Sensors are placed on the signs so when a vehicle is going the wrong way it triggers the signs to go into flash mode. This will alert the motorist that they are going the wrong way. The system also notifies the TMC and law enforcement and also takes a snapshot of the vehicle so it can be tracked through CCTVs. There will be about 30 other locations that will go under construction for this system.
- The MLK Overheight Warning Signs project was recently completed. This system will detect any trucks that are overheight and will activate an alert to let them know to exit either I-95 Southbound or I-95 Northbound. This will prevent them from hitting the bottom of the I-95 overpass.

Announcements

- The next meeting is scheduled for January 19, 2021. at 10 a.m. Due to Covid-19, FDOT will be awaiting guidelines from the Governor to decide when to have the next in-person meeting.
