Tuesday, July 21, 2020 Meeting Minutes

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The May 2020 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Your 10 & 95 Project Updates by Debbie Delgado

- There will be an upcoming traffic shift to the left on Ramp T (Northbound I-95 to Westbound I-10). The area to the right (in front of FDOT's Urban Office) to be completed.
- Structural steel widening is ongoing from Ramp T (Northbound I-95 to Westbound I-10) to the "new" Ramp V (Northbound I-95 to I-10 Westbound, exit to Stockton St.).
- There will be a shared use path next to Southbound Fuller Warren widening. A traffic barrier will be placed on the bridge widening and a decorative rail will be placed on the shared use path.
- Roadway widening and a new noise wall will be constructed on Ramp K (I-10 Eastbound from Stockton to I-95 Southbound) behind the barrier wall to the far right as well as the far left (viewing East and viewing West).
- Deck widening is scheduled on the Fuller Warren Bridge viewing West towards the Interchange.
- There are multiple detours scheduled in the coming days:
 - I-95 to the I-10 West flyover.
 - o I-10 East between McDuff and I-95.
 - Roosevelt North and Stockton on the off ramps.
- The I-95 South Stockton off ramp should be open by early Fall.

Construction Project Update by Debbie Delgado

• Flagging operations for the US 17 widening project are scheduled on the Southbound lanes of US 17 (Dunn's Creek Bridge area).

Emergency Operations Update by Ed Ward

- Some personnel are involved in the Republican National Convention Committee and have been attending teleconferences, webinars, etc.
- There are a few storms out in the Gulf of Mexico and the Atlantic Ocean but none are expected to impact Florida.

ITS Update/ITS Projects/511/TMC Updates by Craig Carnes and Jason Evans

- The I-10 to Tallahassee project should be final accepted soon.
- SR 9B will have ITS added during an upcoming widening project.
- FL 511 The IVR (phone option) will still be disabled although an exact date is not known
 at this time. Once the IVR is disabled, part of the phone system will still be available for
 emergency situations, but callers won't get up to the minute traffic information like they do
 now.
- The RTMC has been busy helping with testing of devices on the I-10 to Tallahassee project.

- There are plans to implement the Road Rangers to 24/7 coverage on 4 routes by mid-August. Dee Dee will let the Team know when the exact date is known and will send out an updated list of what the routes will be like at nighttime. The routes are as follows, but could possibly change:
 - o 2 routes on I-295
 - A route on I-10 to I-75
 - o A route on I-95
- Richard Bame asked if the Road Rangers will provide more coverage during the Republican National Convention. Dee Dee noted they will definitely provide more coverage and she has been working with the District Office on specifics.

• Dee Dee will be contacting Team members to set up a RISC Debrief meeting for RISC incidents that have occurred during the last quarter.
