

# First Coast TIM Team Meeting

## Tuesday, May 19, 2020

### Meeting Minutes

*The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.*

***\*For the health and safety of everyone, this meeting was held virtually to adhere to COVID-19 safety guidelines.***

#### **Introductions and TIM Updates**

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The January 2020 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

#### **Overland Bridge and Your 10 & 95 Project Updates by Bill Kays**

- Drilled shaft installations will begin again throughout the project.
- There is work being done on the median barrier wall.
- Work will begin on bridge joints after Memorial Day.
- The sound wall installation and road widening are upcoming around Stockton Southbound.
- The drainage on US 17 has been cleaned out.
- The structural steel beams will be set for Ramp T after Memorial Day. Ramp A2 (Eastbound on I-10) will require a detour at that time.
- Pete Vega asked Bill to present on the final signing and pavement marking plans at a later meeting.

#### **Construction Project Update by Hampton Ray**

- I-95 has a resurfacing project on Moncrief Creek to SR 111. This project was accelerated due to fewer drivers on the roadway.
- The COVID-19 checkpoint on I-95 at the State Line will continue through at least the end of July. Hampton thanked the TMC for their assistance with this.
- The work activity for the I-10 widening from I-295 toward downtown should begin in the upcoming months.

#### **Emergency Operations Update by Ed Ward**

*Ed was unable to attend, but relayed the following update through Dee Dee:*

- Hurricane Season begins June 1<sup>st</sup>.
- Tropical System Arthur is offshore moving ENE currently.
- The first 4 storm names are: Arthur, Bertha, Cristobal, and Dolly.
- It is predicted to be an average to above average Hurricane Season, with 16 named storms, 8 hurricanes, and 4 major hurricanes predicted.

## Hurricane Season Update by the RTMC Staff

- Communication:
  - The RTMC can be reached 24/7 at (904) 903-2000.
- Event Management During Evacuations:
  - It is important for responders to clear lanes quickly. Jason Evans provided an overview of SafeTow, RISC, RISC Lite, Road Rangers, and District 2 Rangers.
    - SafeTow – This service is provided on interstates and state roads in Duval County. This is not a destination tow but will get a stranded motorist to the nearest exit or parking lot.
    - RISC Lite – There is currently a RISC Lite contract in Alachua County and one for the Express Lanes in Duval County. This is a Class B wrecker which is used to clear the travel lanes, not a destination tow.
    - District 2 Rangers – This service is activated during emergency situations only. They provide services similar to the Road Rangers, but do not carry the equipment to provide temporary MOT.
    - Road Rangers – Motorists can use this service by dialing \*FHP. This service covers all 18 counties on interstates and also includes JTB, SR 9B, and SR 23 (SR 23 is dispatched through the Turnpike). During an evacuation the Road Rangers are available 24/7 on their normal routes and will be prepared to assist with ESU. They are usually activated a few days before an event and stay activated as evacuees re-enter the state/area. The District 2 Rangers will be available to supplement the Road Rangers.
      - The Road Rangers are currently in the process of hiring to make sure they have enough staff for Hurricane Season.
      - Pete reminded the Team that SafeTow can be implemented on arterials during major events such as a hurricane.
    - Pete Vega asked for the asset maintenance contractor or someone in maintenance to give an overview of their plans during evacuations. Richard Bame noted that they are currently going over their emergency management plans and the Emergency Shoulder Use procedures. Jorgensen relayed that whenever we are at risk of a hurricane making landfall in our area, they go out to trim trees, address areas that are prone to drainage issues, etc.
    - Emergency Shoulder Use Presentation (ESU) – Craig Carnes gave a PowerPoint presentation on ESU. The ESU offers a way to add capacity to the existing roadways in the event of an evacuation. Standard Operating Procedures are being put in place for ESU on I-95, I-10, and I-75.
    - Signals – Pete discussed how District 2 handles response, refueling, and repair for signalized intersections. An Emergency Traffic Signal and Generator contract is implemented. A contractor is then activated and staged at a centralized location in Jacksonville to be ready so when the storm passes through, they can quickly address any signal outages.
    - Mobility Share for Wind Sensor Access – The website is no longer available, but the RTMC will be providing a Mobility Share weblink to allow local agencies to log in and view the wind sensor information. This weblink can be accessed through any device such as a computer, smartphone, tablet, etc. The user will enter a username and password (one will be provided to each agency) and then be able to view a live screenshot of the wind sensor page from the RTMC, which is updated hourly.

- WebEOC – The RTMC has ‘view only’ access and the information is entered by Ed Ward at the EOC. Gracie Kennedy noted that DEP only has access at the Tallahassee TMC. No other agencies commented.
- FL 511 – The IVR (phone option) is no longer available but can be accessed through the app or website. Dee Dee mentioned that if someone calls the IVR, it will direct them to the app and/or website.
- Agency Game Plans/SOP – Dee Dee asked for any input from the Team.
  - The DEP will be having an agency-wide Hurricane Response training exercise on June 8<sup>th</sup>- 9<sup>th</sup>. A Hazardous Assessment Response Team is typically implemented through the DEP in the event of a hurricane.
  - Pete asked if other agencies could share their plans and/or SOPs and email them to Dee Dee at [DeeDee.Crews@dot.state.fl.us](mailto:DeeDee.Crews@dot.state.fl.us).

### **Hurricane Open Discussion**

- Bill Kays stated that all construction projects should verify the Contractor’s emergency contact information.
- Dee Dee asked for all agencies to provide any new emergency contact information for hurricane situations. The information can be sent to Dee Dee at [DeeDee.Crews@dot.state.fl.us](mailto:DeeDee.Crews@dot.state.fl.us) or to Misha at [melder@metriceng.com](mailto:melder@metriceng.com).

### **Incident Debrief**

- Dee Dee encouraged the Team to discuss any incidents on the list. The Team had no comments.

### **Open Forum**

- Dee Dee announced that there is a new RTMC Operations contract in place. The incumbent, Metric Engineering was awarded the contract that started on May 2<sup>nd</sup> and it is a 7-year term.

### **Announcements**

- Due to Covid-19, the next meeting will be announced in the upcoming weeks. FDOT will be awaiting guidelines from the Governor to decide when to have the next in-person meeting.
