# First Coast TIM Team Meeting

# Tuesday, May 18, 2021 Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

\*For the health and safety of everyone, this meeting was held virtually to adhere to COVID-19 safety guidelines.

#### **Introductions and TIM Updates**

- Dee Dee Crews opened the meeting and welcomed everyone.
- Dee Dee stated the purpose of this meeting is to come together to reduce incident scene clearance times to deter congestion and improve safety on the roadways. This ensures mobility, economic prosperity, and quality of life; through corporation and communication between the different agencies during any type of incident scene clearance situation.
- The March 2021 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

## Overland Bridge and Your 10 & 95 Project Updates by Tim Heath

- Ramp X is expected to open next week. This ramp goes from I-95 Southbound to I-10 Westbound (Exit 351A).
- Ramp P is also expected to open next week. This ramp goes from Forest St. to I-10 Westbound.
- Ramp S (the Exit 351B ramp) may be closed for re-striping but only for a short term.
- There will be no other major changes to the current traffic patterns at this time. The traffic pattern will remain the same during the day and there will be the regular nighttime lane closures and detours for construction.

### **Construction Project Update by Bianca Speights**

- There are scheduled detours for the I-10 Eastbound and Westbound lanes from US 301 to SR 23 (First Coast Expressway) this week through May 20<sup>th</sup>. These are nightly detours from 9 PM to 5 AM.
- There is a detour scheduled for I-95 North to the I-10 West flyover. This detour is from May 17<sup>th</sup> through May 22<sup>nd</sup> from 10 PM to 5:30 AM.
- There will be a detour tonight for County Road 209 (Clay County) from 9 PM to 5 AM.

## **Pedestrian Walkway Presentation by Craig Carnes**

 Craig provided the Team with a PowerPoint presentation regarding first responder access to the pedestrian walkway that is being constructed across the Fuller Warren Bridge.

# ITS Update/ITS Projects/511/TMC Updates by Craig Carnes and Jason Evans

- Coordination is ongoing regarding ITS for the Fuller Warren Bridge pedestrian walkway.
- The I-10 Widening project is ongoing and involves quite a bit of ITS work including relocation of infrastructure and devices as well as new devices. Final plans have been submitted for Segments 1 & 2. There are some concerns regarding accessibility and maintainability at some of the device sites, so work is being done with the Engineer of Record for those possible issues.

- The is currently no update for the Truck Parking Availability System (TPAS) project. This project consists of installing in ground sensors in all the truck parking areas where the semi-trucks park to detect the presence of a vehicle within those truck parking spaces. This provides messaging to the signs in advance to let people know how many spots are available in the rest areas. This should help reduce the number of semi-trucks parking along the ramps and on the side of the road causing potential safety issues. This is a Statewide project.
- Buckman Bridge ATMS project is ongoing. This project consists of installing small DMS (Dynamic Message Signs) above the lanes for lane control to let drivers know if the lanes are open or closed.
- ITS infrastructure and devices have been installed along all of the Interstates in Florida. Because of this, all roadway construction projects will have to take the ITS into account during the design and construction. The ITS components will either need to be relocated or protected. If it is relocated, a communications plan will be put in place to keep the fiber up, as that is very important since the network is now Statewide.
- The East Beltway Express Lanes project is progressing. The MVDS will need to be tested for accuracy and to make sure they are operational before the lanes open. A 50 car test run will be done just like it was done for the West Beltway Express Lanes before they opened.
- Jason mentioned that the TPAS information will also be posted to the FL 511 website (once
  the system is active). This will help truckers plan their routes out and determine parking
  availability before they get to the locations.
- The FL 511 IVR (phone option) is no longer available. FL 511 is still available through the
  cellphone app and the website <a href="www.FL511.com">www.FL511.com</a>. Live camera streaming videos are now
  available through the website as well.
- The RTMC has been preparing for Hurricane Season.
- The first Wrong Way Driving system is in place on Lem Turner exit ramps. The plan is to have several new Wrong Way Driving deployments at different ramps around Jacksonville. These systems detect when a vehicle is going the wrong way on the ramp and sends an alert to the TMC and FHP.

#### **Incident Debrief**

 Dee Dee encouraged the Team to discuss any of the incidents on the list, but the Team had no comments or questions.

## **Emergency Operations Update by Carrie Stanbridge**

- Preparation for Hurricane Season has been underway including the addition of generators to the Rest Areas.
- The updated ESU (Emergency Shoulder Use) plans should be finalized soon.
- There is an ongoing effort to ensure all contacts are up to date for FHP, emergency managers, etc. in each county.
- Wind and water gauges along bridges in the District were tested and are working properly.
- The EOC has been asked to put cameras on the fuel decks on Heckscher Dr. to monitor
  the traffic conditions due to the pipeline issues going on. Carrie thanked the TMC and FHP
  for their efforts in monitoring that traffic to make sure there was no interference. Fuel levels
  are still being monitored and vendors have relayed that they have been having a hard time
  getting CDL drivers.

#### **Hurricane Season Update by Dee Dee Crews and Jason Evans**

- Dee Dee stressed the importance of communication with the RTMC. The RTMC can be reached 24/7 at (904) 903-2000.
- Event management during evacuations:
  - SafeTow This service is provided year-round on interstates and state roads in Duval County and Nassau County. This is not a destination tow but will get a stranded motorist to the nearest exit or parking lot.
  - RISC Lite There is currently a RISC Lite contract in Alachua County and one for the Express Lanes in Duval County. The service has been extended to the Buckman Bridge for the Express Lanes, Monday through Friday from 6 AM to 7 PM. This is a Class B wrecker which is used to clear the travel lanes, not a destination tow.
  - District 2 Rangers This service is activated only during emergency situations to supplement the Road Rangers. They provide services similar to the Road Rangers, but do not carry the equipment to provide temporary MOT.
  - Road Rangers Motorists can use this service by dialing \*FHP. This service covers all 18 counties on interstates and also includes JTB, SR 9B, and SR 23 (SR 23 is dispatched through the Turnpike). During an evacuation the Road Rangers are available 24/7 on their normal routes and will be prepared to assist with ESU. They are usually activated a few days before an event and stay activated as evacuees re-enter the state/area. The District 2 Rangers will be available to supplement the Road Rangers.
  - There is a SafeTow program for arterial roadways but it is not used very often. This service is for lane blocking events to clear the roadway and remove vehicles out of the travel lanes. This can also be activated by dialing \*FHP and dispatched through the TMC.
  - RISC (Rapid Incident Scene Clearance) This program is also available and the criteria is often more lenient during event management in evacuations.
- Dee Dee encouraged the asset maintenance contractors to share their plans during hurricane evacuations.
- ESU (Emergency Shoulder Use) The ESU offers a way to add capacity to the existing roadways in the event of an evacuation.
- Signals District 2 handles response, refueling, and repair for signalized intersections. An
  Emergency Traffic Signal and Generator contract is implemented. A contractor is then
  activated and staged at a centralized location in Jacksonville to be ready so when the storm
  passes through, they can quickly address any signal outages.
- Mobility Share for Wind/Water Sensor Access The website is no longer available, but the RTMC will be providing a Mobility Share weblink to allow local agencies to log in and view the wind sensor information (only when a storm is imminent and through its duration). This weblink can be accessed through any device such as a computer, smartphone, tablet, etc. The user will enter a username and password (one will be provided to each agency) and then be able to view a live screenshot of the wind sensor page from the RTMC, which is updated hourly. - WebEOC The RTMC has 'view only' access and the information for the District is entered by a representative at the EOC.
- FL 511 The IVR (phone option) is no longer available but can be accessed through the app or website. Dee Dee mentioned that if someone calls the IVR, it will direct them to the app and/or website.
- Agency Game Plans/SOP Dee Dee asked for any input from the Team and would be willing to have a separate meeting to discuss this. She also asked for everyone to email her their emergency contact information at DeeDee.Crews@dot.state.fl.us.
  - Major Harris thanked the Team for all the information provided and reiterated how helpful it is especially during storms and evacuations.

- The next meeting is scheduled for July 20, 2021, at 10 a.m. Dee Dee plans on speaking to her manager to see if some type of in person meeting will be feasible. She will let the Team know before July.
