- Dee Dee stated the purpose of this meeting is to gather everybody together to coordinate and improve cooperation to clear the roadways sooner for everyone's safety and try to figure out ways to improve our roadway clearance times.
- The June Alachua/Bradford TIM Team meeting minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Emergency Operations Update by Lola Butler

- In the process of updating the District 2 SharePoint Page. The page will be similar to D5 and more user friendly for everyone once it is complete, the link will be sent out.
- Provided the storm updates. There has been a reduction in the number of predicted storms. Although it is a slow start to the hurricane season, that is normal for this time of year and September is the peak hurricane season.
- Dee Dee stated that the RTMC in Jacksonville has double checked their Hurricane supplies (air mattresses, updated dry goods, First Coast Road Rangers are on standby for 24/7 service, safety meetings).

Maintenance Operations Update by Carrie Stanbridge

- Carrie introduced and welcomed Austin Woodington.
- Carrie stated that as of midnight on August 11th, I-75 welcome centers, and weigh stations would be under a new contractor (under Walsh group). Carrie asked everyone to please inform her of any issues.
- Oasis Landscaping is covering Alachua rest areas and I-75, everything else is under Walsh group.
- On I-75 and I-10, the new maintenance contract does not include bridges.
- The beam hit at Ellisville was fixed. It has been hit 2 more times after being fixed.
- There are concerns going into Hurricane Season that beams will continue to get hit.

- The Gainesville TMC is continuing to monitor and change signal timings when needed.
- No new ITS projects currently.
- The 511 app is in the process of updating with new features. Multiple my camera routes.

 complete.
