Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Dee Dee stated the purpose of this meeting is to gather everybody together to coordinate and improve cooperation to clear the roadways sooner for everyone's safety and try to figure out ways to improve our roadway clearance times.
- The August Alachua/Bradford TIM Team meeting minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Emergency Operations Update by Adam Doyle

- October 12th marked 19 days of storm recovery after Hurricane Ian
 - In District 2, there was localized flooding and downed trees
 - Two FDOT facilities lost power and had to be powered by the backup generators
 - Minimal infrastructure damage along A1A, Heckscher Dr, and Mayport Rd
 - Department employees are deployed for recovery assistance in Districts 1, 5, & 7
 - Orlando is completing debris recovery

Maintenance Operations Update by Adam Doyle

- Remodel/upgrade to Rest Areas throughout the District should be complete by end of year

ITS/511/RTMC Update by Jason Evans

- Jason Evans advised that there are still 1.5 months left in Hurricane season and the RTMC remains prepared for any big storms
- There is not much regarding construction in the western side of the District
- Continuing issues w/ the pucks for TPAS (Truck Parking Availability System)
 - The pucks are unable to keep charge, looking for other solutions.
 - Additional cameras may be deployed to monitor available spots until puck issue is able to be fixed
- FL511 app is up and running. Should be able to load into drive mode when connected in car and be completely hands free.
 - Can provide feedback in the app itself. The app can report things if not already reported (i.e., debris, crashes, etc.)
- D2 almost fully recovered from Hurricane Ian.
 - There's ongoing monitoring of water levels
 - Dee Dee stated that we added 2 additional Road Rangers on I-10 and I-75 from Tuesday PM to Saturday AM, as well as tow trucks to assist motorists evacuating if needed.
 - Starting Monday, 10/17, Route 15 will be changed into a 24/7 route. with the addition of this overnight route, anything west of I-75 will have full coverage
