Meeting Minutes

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Dee Dee stated the purpose of this meeting is to gather everybody together to coordinate and improve cooperation to clear the roadways sooner for everyone's safety and try to figure out ways to improve our roadway clearance times.
- The October Alachua/Bradford TIM Team meeting minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Emergency Operations Update/Maintenance Operations Update: Carrie Stanbridge

- The EOC continues to pick up debris across West Florida
 - To date, 7.2 million cubic yard of debris have been collected and removed
 - Work will continue in the pits, where debris will be reduced to mulch then moved to the final disposal location
- Moving into the new year, Hurricane Idalia recovery will shift to reimbursement
 - Permanent works are underway
 - Lighting has been repaired
 - Task work orders to repair/replace signage have been written and orders have been placed with the State sign shop
 - Damaged fencing along I-10 will be replaced in early 2024
- The Rest Area at US-19 experienced a water break, so portable toilets were used while repairing
- Road work and lane closures will not be occurring during the holiday season
- All units have picked up winter weather plans, including reassessing salt, plows, and who is responsible for what
- All teams on alert for Rest areas to ensure they have sufficient attendants
- Two bridge locations on the northwest side of the District, near the FL/GA line, experienced washouts
 - Currently working to repair these
- Maintenance is currently focused on ditches and reclaiming the fence lines
 - AM contractors are working on the areas between the ditch line and fence line on the interstates
 - DCS has been aggressively clearing this area
 - This work is part of the regular maintenance activities and is not Hurricane Idalia related
- The Welcome Center in Hamilton has experienced issues with its roof leaking
 - Looking to get this fixed before the holiday traffic

ITS/511/RTMC Update: Jason Evans

- There is an ongoing issue with spiders on the RWIS sensors in the Paynes Prairie area
 - Currently working with the contractor to spray and mitigate spiders in an effort to keep them off of the devices

- Began ITPAS – Intelligent Truck Parking Availability System – which uses cameras to detect filled parking spots at Rest Areas
 - The in-ground pucks were not working as well as hoped
 - The first testing of the ITPAS system was met with 95% accuracy, and they are still making tweaks to improve the reliability of the system
 - The Columbia/Suwannee Rest Area has not been updated yet and is still utilizing the in-ground pucks
- There are blind spots on both I-10 and I-75 due to trees in the medians
 - Looking to place cameras at these locations as well as tree trimming to reduce these blind spots
- The FL511 app was updated in Mid-September
 - New features were added, such as links to additional 511 resources, link to quick call *FHP if assistance is needed, updated map interface
 - Jason advised that the app did not prompt any of the Team to update, so it is advised to go into the Play Store/App Store and manually update the app to receive the updated features

Performance Measures Presentation: Taylor Rouse

- Taylor provided the Team with a Performance Measures Presentation.

Open Forum

- Dee Dee advised that the RISC Lite on I-75 has been replaced with a 24/7, Class B tow truck that can tow up to a box truck
- The entire Road Ranger fleet across District 2 are now propane-powered vehicles, making it the only Green Fleet in the State of Florida
- Chris Gilbert, with Alachua County Environmental Protection, advised they are working to transition to hazardous materials emergency response, and is looking for support to pass onto the County Manager
