Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone
- Dee Dee stated the purpose of the meeting is to partner together to reduce incident scene clearance times, to deter congestion, and improve safety for everyone on the roadway.
- The March 2023 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Your 10&95 Project Update: Tim Heath

- The project is functionally complete, with only a few punch list items remaining.
 - There will be continued closures and detours while these items are completed.
- The Shared Use Path opened on 4/3.
- This will be the last 10&95 project update as the project is completed.

Construction Project Update: Nathan Pick

- There are a few upcoming construction open houses.
 - Thursday, May 18th, Edgewood Roadway Improvements Project
 - This project will have some lane reassignments, with parking and bike lanes being installed.
 - The project will begin Summer 2023 and roll into Summer 2024.
 - Open House will be at the FDOT Urban Office Training Center from 4:30 PM to 6 PM.
 - Tuesday, May 23rd, St. Johns River Bridge Project
 - Open House will be at the Clay county Supervisor of Elections Office from 4:30 PM to 6:30 PM.
- There will be upcoming nightly ramp detours on I-10 at McDuff, Roosevelt, at the I-10/I-295 W Beltway interchange, and at the northern I-95/I-295 interchange.

Emergency Operations Update: Lola Butler

- Ongoing preparations for the hurricane season, which begins on June 1st.
- The EOC has completed all Emergency Shoulder Use page-turners.
 - There is a pending trial run for ESU on either 5/30 or 5/31, Lola to reach out with final date.
- Colorado State University has predicted a fairly mild hurricane season, with only 13 predicted storms.
- Lola urged everyone to ensure all contact information is correct.
- The D2 EOC is under construction, with a completion goal of the next 14 days.

Maintenance Operations Update – Lola Butler

- Invoicing for AM's – need to ensure they have timesheets because they will not get reimbursed if not.

ITS Update/ITS Projects/511/TMC Updates: Craig Carnes/Jason Evans

- Craig Carnes advised the ITS group is working closely with all construction projects to ensure fiber is not hit and ITS devices are protected or relocated during construction if needed.
 - There was a major fiber hit on the Skate Park that is going under the Fuller Warren Bridge.
 - Currently has a temporary fix, with a permanent fix coming soon
- There was a push from FDOT to get Wrong Way Driving Systems deployed on all of the ramps.
 - A lot of the ramps that have had WWD issues in the past have been covered.
 - Currently around 30 WWD devices currently deployed, with 30 ramps covered and around 6 more in the works for ongoing projects.
- In the more rural areas, WWD systems are being put in during any kind of widening or rehab projects.
- Signs are red and white with LED blinkers that go around the perimeter of sign, and the system includes cameras that take video of vehicles that are going the wrong way.
 - The devices record vehicles leading up to and after the devices, so they can see if the vehicle self-corrected.
 - The TMC receives WWD alerts and can post messages on DMS to let drivers know there is a potential WWD in the area.
 - Can also inform FHP that there is a WWD to try and prevent accidents.
- If there is a crash involving a WWD sign, notify the TMC and safe up all wires.
- Jason advised there are no new FL511 app updates, but they are pushing the app for the upcoming hurricane season.

- The RTMC is currently in hurricane season prep mode, ensuring all supplies and documentation are up to date.

Performance Measures Presentation: Taylor Rouse, James Maly

- Taylor Rouse and James Maly provided the Team with the Performance Measures Presentation.

Incident Debrief

- James Maly with Jorgensen advised that the communication during RISC events has been great since the last meeting.

Open Forum

- There was a wildfire in Nassau a few weeks ago, they brought in a Helo and got it under control.
 - The area is currently dry, but they are still issuing burn authorizations.
- Dee Dee advised there are current statewide safety initiatives, which include changes in lighting in RR trucks.
 - Rear facing red lights, which help the Road Rangers to be seen
 - District 2 is the first district to have rear facing lights put on
 - Road Rangers can only use these when at an event
 - Lighted flares at night to put under cones
