

First Coast TIM Team Meeting

Tuesday, September 19th, 2023

Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone
- Dee Dee stated the purpose of the meeting is to partner together to reduce incident scene clearance times, to deter congestion, and improve safety for everyone on the roadway.
- The July 2023 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Construction Project Update: Nathan Pick

- There were overnight detours at the I-10/I-95 interchange the week of 9/18/2023
- Numerous detours from 9/17/2023 to 9/21/2023 for the I-10 Widening
- Detours for the I-10 at US-301 Interchange (I-10 EB exiting off onto US-301) began on 9/20/2023
- Operation improvements for the I-295 at Normandy resurfacing starts this summer and will be running through summer 2024
 - To include overnight work and will be seeing changes to this interchange

Emergency Operations Update: Carrie Stanbridge

- The EOC is still responding to impacts from Hurricane Idalia, especially on the western side of the District
 - The D2 EOC has been working to clean-up the Counties that were hit especially hard during the Hurricane, and is currently working to clean up the county roads in the following areas
 - Steinhatchee, Horseshoe Beach, Cedar Key, and Keaton Beach
 - There has been a lot of activity on I-10 in both Madison and Suwannee Counties as they remove debris from the side of the Interstate
 - Clean up operations have been occurring on US-90 in Madison County
 - There has been an increase in trucks for hauling and cut crews on I-75 in both Hamilton and Suwannee Counties
 - State Roads in Columbia, Levy, Suwannee, Taylor, Hamilton, Dixie, and Madison Counties are seeing 2nd and 3rd passes of debris removal
 - There are close to 137 trucks in action across the western portion of the District
 - There were two accidents on I-10 over the weekend (9/15/2023 – 9/17/2023)
 - Lane closures and MOT were implemented in both cases
 - A CEI was injured in one of these incidents, but is currently doing fine and was back on the job

Maintenance Operations Update: Carrie Stanbridge

- Carrie advised they are currently adjusting a lot of the contracts in house, including some MOT contracts and additional support contracts for bridge crews

- Working to get contracts in place for the wildlife fence along I-10, from Madison County to Suwannee County as a lot of it was damaged during Hurricane Idalia
 - Will replace all fencing that was damaged
- Also working to get contracts in place for sign replacements as a lot of the big signs were taken out on the western side of the District during the Hurricane
- On 9/19/2023, there was a closure on I-95 to fix a hole in the bridge deck
 - Teams were on scene at night on 9/19/2023 to repair this hole
- Crews are currently in the process of repaving I-10
- Carrie advised they are also in the process of replacing/repairing the 30+ light poles that were damaged/downed during the Hurricane
- Richard Bame advised that the portion of the Yellow Line of paint that was on the asphalt was painted black, and the portion that was on concrete was about 90% removed as of 9/19/2023

ITS Update/ITS Projects/511/TMC Updates: Craig Carnes/Jason Evans

- Craig Carnes advised that there is ITS work being included in upcoming big projects, such as the I-10 widening, and the I-10/I-295 interchange
- Jason Evans advised there is an upcoming MLK Project that spans from I-95 to the Hart Bridge, and from the Hart Expressway down to Atlantic Beach
 - Installing fiber and ITS devices along this corridor
 - This is a 1+ year project and expect the project will be online in late 2024
- Pete Vega advised there is a project at Blount Island, tying into the truck traffic in the area
 - Includes adaptive systems on the I-295 interchange
 - There was a follow-up meeting with JAXPORT on 9/20/2023 to see how they can add technology on campus at both the Talleyrand and Blount Island Terminals to try and make traffic flow better and increase freight
- Pete Vega also advised that on Heckscher Drive at Zoo Parkway, there is a planned deployment to detour freight and redirect them to either I-295 or I-95, along with the implementation of rail detection
 - Rail detection is currently being deployed at 70 locations initially, with more to come
 - Initially being deployed along US-17 from I-95 down to CR-220 in Green Cove Springs, and US-1 from South Bank down to CR-16 in St. Johns County
 - The goal is to let motorists know about gate closures, so they can seek alternate routes if needed, along with providing capabilities to first responders to potentially reroute if necessary
 - This system will be tied into SunGuide and posted to DMS
- The FL511 app is in the process of undergoing a facelift, with improvements in both look and functionality
- The State is in the process of switching to a new Express Lane Software, called NG SELS
 - This new software will be going into testing within the next month or two, and hopefully early 2024 the District will switch to the new software
 - District 2 will be the first in the State with this new software
- A new lane control software system will be added into the current software to control the gantries that were installed over the Buckman Bridge in both directions
 - This project still has a year until completion, but testing on the off-bridge portion should be completed soon

- Taylor Rouse and James Maly provided the Team with the Performance Measures Presentation.
