### Meeting Minutes

#### **Introductions and TIM Updates**

- Dee Dee Crews opened the meeting and welcomed everyone.
- Dee Dee stated the purpose of this meeting is to gather everybody together to coordinate and improve cooperation to clear the roadways sooner for everyone's safety and try to figure out ways to improve our roadway clearance times.
- The April Alachua/Bradford TIM Team meeting minutes were sent to the Team previously, and receiving no comments, they stand as approved.

#### **Emergency Operations Update: Jason Evans**

- The 2024 Hurricane Season will go from 6/1/2024 through 11/30/2024.
  - Colorado State University is predicting an extremely active Atlantic Hurricane season.
    - Coverage areas include the Atlantic Ocean, the Gulf of Mexico, and the Caribbean
  - The Colorado State Team forecasted 23 named storms, including 11 hurricanes.
    - Five of these 11 hurricanes are predicted to be Category 3 or greater.

#### **Maintenance Operations Update: Dee Dee Crews**

- The RTMC is preparing for hurricane season

#### **ITS/511/RTMC Update: Jason Evans**

- All generators and Master Hubs have been topped off with fuel in case power outages occur due to storms.
- They are continuing to add cameras along the interstates and ramps where there are gaps in coverage.
- Ensure your FL511 app is up to date
  - A new update is expected to be released Summer 2024
- The RTMC has completed their hurricane prep checklist, which includes stocking up on batteries and food, completing generator tests, and ensuring sleeping arrangements are in place.
- Dee Dee advised that the Road Rangers are aware that routes could become 24/7 in the case of emergencies.

- Taylor provided the Team with a Performance Measures Presentation.
