Tuesday, March 19th, 2024

Meeting Minutes

The list of attendees, agenda, and meeting handouts are attached to these meeting minutes.

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone
- Dee Dee stated the purpose of the meeting is to partner together to reduce incident scene clearance times, to deter congestion, and improve safety for everyone on the roadway.
- The January First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Construction Project Update: Sara Pleasants

- There will be continued detours and road closures at the I-95/I-295 northern interchange, and traffic shifts can be expected as construction is completed over the next few months.
- There is an upcoming Emerson Expressway resurfacing project.
 - Work on the SB lanes is scheduled to begin 4/5/2024 and will be completed within 2 weeks.
 - Work on the NB lanes will begin on 4/19/2024 and will be completed within 2 weeks.

Emergency Operations Update: Carrie Stanbridge

- Carrie advised that Hurricane Idalia cleanup has been completed as of mid-March.

Maintenance Operations Update: Richard Bame

- Richard advised that the southern most St. Johns County Rest Areas underwent drain cleaning for both the sinks and the toilets.
 - Work was completed in steps to not reduce any capabilities of the rest area for travelers.

ITS Update/ITS Projects/511/TMC Updates: Craig Carnes/Jason Evans

- Craig advised that there are several ongoing projects throughout the District 2 region. The ITS Group works in close coordination with all projects to ensure the Fiber Optic Cable infrastructure is not damaged at any point in the construction process.
 - The Buckman Bridge ATMS project is still ongoing.
 - There have been issues with the mounting of the cabinets over the water. A solution is being investigated.
 - The I-10 widening project has been going smoothly, with no recent fiber cuts or power outages.
 - There are two new MLK Parkway projects, one of which is at the I-5 Interchange, to address the issues of trucks hitting the bridge. The second project is to the east of the Interchange Project.
 - I-95 widening project from Emerson to Atlantic
 - The DMS within the project limits will need to be removed, so the RTMC is working to get a temporary DMS installed.
 - The moveable bridge project is approximately 50% completed.

- Upon completion, bridge tenders for the six moveable bridges in the region will be able to better monitor pedestrian traffic as the bridge rises and lowers.
- The SMART St. Augustine project is a high paced project which received federal funds via the RAISE Grant.
 - This project is currently in its PD&E phase and will focus on Downtown St. Augustine.
 - This project will look into parking alternatives, enhance the Visit St. Augustine smartphone applications, implement audible pedestrian countdowns, install mobility hubs which will provide EV charging stations, and include the installation of ADMS, parking signs, and flood sensors.
- Jason Evans advised the FL511 app is continuing to improve, and they are in the early stages of testing expansion for Connected Vehicle and Emergency Vehicle applications for the app.
 - The pilot project is currently ongoing in District 5.
- The ITS Group is working with a company called TRAINFO to provide railroad crossing notifications to motorists and emergency responders to allow time for detours if necessary.
- Hurricane season is quickly approaching and the RTMC is taking precautions to ensure their supplies are ready and documentation is up to date.

Performance Measures Presentation: Taylor Rouse/Gerald Smith

- Taylor Rouse and Gerald Smith provided the Team with the Performance Measures Presentation.

Incident List: Team

- It was discussed that moving forward, the addition of a HAZMAT column and changing the “Deaths” column to a Traffic Homicide Investigation (THI)/Serious Bodily Injury (SBI) column will be present for future incident lists.
 - This will help the team understand why certain events have high incident durations when a fatality did not occur at the event.
