- Jason asked the Road Rangers to please make sure you advise the dispatcher where exactly you are at. Right shoulder, left shoulder.
- Jason advised that CJ was present and is updating the phones and tablets. Jason also advised them that they will not notice a difference. This should however help with some of the problems they were having getting logged out and such.
- Dee Dee asked them to please make sure you keep up with your radios.
- Sherrell advised that the Road Rangers get a 15-minute break per shift and to please not take breaks during peak hours. She also asked to please make sure the trucks are on the road by 7am. And make sure the GPS is turned on.
- Sherrell also informed the Road Ranges that "Personal's" are considered a part of your break times.
- Sherrell also asked them to please make sure they are logging in the correct route number, driver and radio.
