Meeting Minutes

Introductions and TIM Updates

- Dee Dee Crews opened the meeting and welcomed everyone.
- Attendees introduced themselves to the group.
- The purpose of this meeting is to improve Communications, Coordination, Cooperation and Collaboration between all TIM agency partners, as well as to improve safety and congestion on the highways.
- The March 2019 First Coast TIM Team Meeting Minutes were sent to the Team previously, and receiving no comments, they stand as approved.

Overland Bridge and Your 10 & 95 Project Updates by Bill Kays with KCCS

- The Overland Bridge project has been final accepted. The project consisted of 2,447 contract days.
- The I-95 Interchange project is on schedule.
 - Eastbound I-10 was detoured to remove an overhead structure at Stockton St.

Construction Project Update by Hampton Ray

- There will be a detour on I-10 eastbound at US 301 next Thursday overnight from 9 pm to 5 am.
- Hampton thanked law enforcement for their efforts in keeping the traffic calm with the opening of the Express Lanes.

Emergency Operations Update by Ed Ward

- ***Ed was unable to attend but wanted to relay the message that Hurricane Season is upon us so for everyone to be prepared as possible.***

ITS Update/ITS Projects – 511/RTMC by Craig Carnes and Jason Evans

- The Overland Bridge project has been final accepted and the final set of as-builts should be turned in soon.
- The I-95 Nassau County project is wrapping up. This project will extend ITS coverage up to the Georgia line.
- Now that the West Beltway is open, final Microwave Vehicle Detection System (MVDS) testing will be conducted.
- The I-10 Project from SR 23 to Tallahassee is underway.
- The East Beltway Express Lanes should be completed this Fall.
- Central Office has been working with the 511 contractor on an update to allow operators to add events in 511 that occur on non-covered roadways. This will be extremely helpful during hurricane season when events occur that shut down state roads without ITS coverage.
- The RTMC Operators are getting prepared for the recent opening of the Express Lanes and the upcoming opening of the First Coast Expressway.

Road Ranger Update by Dee Dee Crews

- The Express Lanes currently have a Road Ranger on duty 24/7. They will remain 24/7 for the first 90 days and then the need will be reevaluated.
- Once the First Coast Expressway opens there will be one Road Ranger available Monday through Friday from 6:30 a.m. to 6:30 p.m. The Road Ranger will be dispatched from the Jacksonville RTMC.

Incident Debrief

The Team discussed the following:

- Greg noted that a Road Ranger was hit on I-95 near Pecan Park Rd. The rear of the Road Ranger's truck was clipped in the rear causing it to overturn on it's side. The Road Ranger was shaken up but is expected to be ok. This incident will be discussed during the Performance Measures Presentation later in this meeting.
- Dee Dee encouraged the Team to discuss any of the incidents on the list.

Performance Measures by Sherrell Lall

- Sherrell provided the team with a Performance Measures presentation.

Incident Review by Gerald Smith with Jorgensen

- Gerald provided the Team with a presentation reviewing several incidents.

Open Forum

- A JEA downed power line was called in to the Asset Management Contractor. This was JEA's issue, but they did not respond to the callout for 9 hours so the Asset Management Contractor had to sit there the entire time. There were also issues with JSO arguing with their personnel that MOT was needed. Dee Dee will attempt to set up a meeting with JSO to discuss this issue and others. Laura Simpson noted that she has a contact at JEA that may be able to help with the issue of JEA's long response time.

- Mike Rollins, the Turnpike's Asset Maintenance Project Manager, stated that Ferrovial Services will be the Asset Management Contractor on the First Coast Expressway. 90% walkthroughs have been completed. The tolling equipment is functional although tolls are not being charged.
